Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through an open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 otherwise known as the "Government Procurement Act."

Bidding is restricted to Filipino citizen/sole proprietorship, partnership, corporations and organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizen or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested eligible bidders may obtain further information from the BAC Office and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II, Instruction to Bidders.

A complete set of Bidding Documents may be acquired by the interested bidders at the address below and upon payment of non-refundable fee for the bidding documents, pursuant to the latest Guidelines issued by the GPPB.

The Bids & Awards Committee will hold a Pre-Bid Conference on **August 17, 2016 at 2:00 P.M. at BAC Office, Multi-Purpose Hall "B", 2F, City Hall Bldg., City of Naga, Cebu** which shall be open only to all interested parties who have purchased the Bidding Documents. Bidders are encouraged to raise all their queries about the project/s concerned during the said conference.

Bids must be delivered **on or before 2:00 P.M. of August 30, 2016 at the BAC Office, Multi-Purpose Hall "B", 2F, City Hall Bldg., City of Naga, Cebu**. Bid opening will be at **2:00 P.M.** at the said address. All Bids must be accompanied by a bid security in any of the acceptable forms or Bank Guarantee in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders or its authorized representatives who choose to attend the proceeding. Late Bids shall not be accepted.

The BAC of the City of Naga, Cebu reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
