**RESOLUTION NO. 007-B-2006**

WHEREAS, the Bids & Awards Committee of this municipality, represented by Mr. Teofilo V. Camomot has submitted a letter of request for the passage of an Ordinance imposing fees for bid documents and forms;

WHEREAS, after a thorough deliberation, it was agreed by all members of the Sangguniang Bayan of Naga, Cebu, on motion of Hon. Pablo A. Abangan, to promulgate the following Ordinance:

**ORDINANCE NO. 2006 - 0001**

**AN ORDINANCE IMPOSING FEES TO PROSPECTIVE BIDDERS WHO INTENDS TO PARTICIPATE IN EVERY BIDDING TO BE CONDUCTED BY THE BIDS AND AWARDS COMMITTEE OF THIS MUNICIPALITY**

BE IT ENACTED by the Sangguniang Bayan of Naga, Cebu that:

SECTION 1. Imposition of Fees. The following fees shall be imposed to suppliers, dealers, manufacturers, contractors, consulting services and other service companies, etc. who wish to participate in any bidding proceedings conducted by the Bidders and Awards Committee of this municipality, to wit:

A. Issuance of Bidder's Eligibility Forms	-P	50.00/bid
B. Issuance of Bid Documents:		
B.1. Goods with corresponding total cost or value:		
Php 100,000.00 and below	-P	250.00
500,000.00 and below (>100,000.00)	-	500.00
1,000,000.00 and below (>500,000.00)	-	1,000.00
2,000,000.00 and below (>1,000,000.00)	-	2,000.00
Above P2,000,000.00	-	3,000.00
B.2. Infrastructures (and other straight contracts)		
Php 1,000,000.00 and below	-	2,000.00
Above P1,000,000.00	-	3,000.00
B.3. Consulting Services and other service companies:		
Php 1,000,000.00 and below	-	1,000.00
Above 1,000,000.00	-	3,000.00
B.4. Specialty Projects (e.g. IT rights, intellectual rights, exclusive products)		
Php 1,000,000.00 and below	-	1,000.00
Above P1,000,000.00	-	3,000.00
C. Issuance of BAC related Certifications	-	50.00

SECTION 2. The fees shall be paid to the Municipal Treasurer or his authorized representative prior to the conduct of bidding, the proceeds of which shall be treated as Trust Fund to be used as funding source for honorarium of the members and Technical Working Group of the Bids and Awards Committee, as provided for under Section 15 of the Government Procurement Reform Act (Republic Act 9184) and Section 5 of the Budget Circular No. 2004-5.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately.
