



RESOLUTION NO. 004-E-2011

WHEREAS, there is a need to re-organize the Naga Tourism and Heritage Development Council (NTHDC) in order to efficiently and effectively carry out its mandated function;

NOW THEREFORE, Be it resolved by the Sangguniang Panlungsod of Naga, Cebu to enact as it hereby enacts the following Ordinance:

ORDINANCE NO. 2011-001

AN ORDINANCE RE-ORGANIZING THE CITY OF NAGA TOURISM AND HERITAGE DEVELOPMENT COUNCIL (NTHDC), AMENDING FOR THAT PURPOSE CERTAIN PROVISIONS OF ORDINANCE NO. 004-2008"

Section I. Section V of Ordinance No. 004-2008 is hereby amended as follows:

COMPOSITION: The Naga Tourism and Heritage Development Council (NTHDC) shall be composed of the following:

- a.) *Chairperson: The City Mayor*
- b.) *Vice-Chairperson: The Chairman, Sanggunian Committee on Tourism and Socio-Cultural Affairs*
- c.) *Ex-Officio Members:*
 - c.1. *Chairman, Sanggunian Committee on Infrastructure*
 - c.2. *Chairman, Sanggunian Committee on Education*
 - c.3. *Chairman, Sanggunian Committee on Environment*
 - c.4. *City Engineer*
 - c.5. *City Planning & Development Coordinator*
 - c.6. *City Information Officer*
 - c.7. *City General Services Officer*
 - c.8. *City Budget Officer*
 - c.9. *City Treasurer*
 - c.10. *City Schools Division Superintendent*
 - c.11. *City DILG Operations Officer*
 - c.12. *Barangay Captains of component barangays*
- d.) *Other Members: Such other persons, including representatives from other Local/National Government Agencies, the private sector and academe, whose expertise and experience shall be valuable to the NTHDC may be appointed by the City Mayor as members.*

Section II. Section VI of Ordinance No. 004-008 is hereby amended as follows:

TERM OF OFFICE: Except for those enumerated in Section V a, b, and c hereof who are ex-officio members of the NTHDC, the other members of the NTHDC shall be appointed

by the City Mayor for a term of one(1) year, which may be renewed for the same or longer period at the discretion of the City Mayor.

Section III. Section XI of Ordinance No. 004-2008 is hereby amended as follows:

STAFF:

- a.) *The following Technical Working Groups (TWG) are hereby created to assist and provide staff work, in the efficient implementation of the purposes, functions and powers of the NTHDC:*
 - b.1. *Technical Working Group on Language, Culture and the Arts*
 - b.2. *Technical Working Group on Tourism*
 - b.3. *Technical Working Group on Heritage Sites, Relics and Structures*
 - b.4. *Technical Working Goup on Documentation and Secretariat*
- b.) *Each TWG shall have a Team Leader from among ex-officio members of the NTHDC. Members of the TWG shall be appointed by the City Mayor from among organic personnel of the local government unit or private persons whose expertise and experience may be valuable to the NTHDC-TWG.*
- c.) *The City Mayor may appoint an Executive Director for the NTHDC from among its ex-officio or other members, whose main function, duty and responsibility is to manage and oversee the day-to-day operations of the NTHDC.*


Section IV. SEPARABILITY CLAUSE. Should any provision of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect.

Section V. REPEALING CLAUSE. Ordinance No. 004-2008 and any and all Ordinances or provisions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


Section VI. EFFECTIVITY. This Ordinance shall take effect immediately.


