**APPROPRIATION ORDINANCE NO. 2014-001**

**APPROVAL OF SUPPLEMENTAL BUDGET NO. 01 FOR FISCAL YEAR 2014 OF THE CITY OF NAGA, CEBU AMOUNTING TO THREE MILLION EIGHT HUNDRED FORTY THREE THOUSAND FIVE HUNDRED EIGHTY PESOS AND 23/100 (P3,843,580.23)**

WHEREAS, presented and subjected to deliberation by this Body was Supplemental Budget No.01 for Fiscal Year 2014 covering various appropriation items under the General Fund - Proper of the City of Naga, Cebu amounting to THREE MILLION EIGHT HUNDRED FORTY THREE THOUSAND FIVE HUNDRED EIGHTY PESOS AND 23/100 (P3,843,580.23), endorsed from the Office of the City Mayor for approval;

WHEREAS, a Certified Statement of Funding Sources issued by the City Treasurer on March 10, 2014 shows that the amount of THREE MILLION EIGHT HUNDRED FORTY THREE THOUSAND FIVE HUNDRED EIGHTY PESOS AND 23/100 (P3,843,580.23) is sourced out from realignment/reversion of unexpended funds under the General Fund - Capital Outlay (Land Improvements);

WHEREAS, after a thorough scrutiny, this Body deemed it appropriate to approve the said Supplemental Budget, so as to facilitate disbursement of expenditures deemed necessary for the smooth and effective operation of this local government unit;

**NOW THEREFORE, BE IT ENACTED** by the Sangguniang Panlungsod of the City of Naga, Cebu that:

Section 1. Supplemental Budget No. 01 for Fiscal Year 2014 of the City of Naga, Cebu, (*per attached copy*) containing various appropriation items under the General Fund - Proper amounting to THREE MILLION EIGHT HUNDRED FORTY THREE THOUSAND FIVE HUNDRED EIGHTY PESOS AND 23/100 (P3,843,580.23) **IS HEREBY APPROVED.**

Section 2. Effectivity. This Appropriation Ordinance takes effect immediately, upon approval.
