**ORDINANCE NO. 2014-006**

**AN ORDINANCE CHANGING THE NAME OF "NAGA CENTRAL ELEMENTARY SCHOOL" TO "CITY OF NAGA CENTRAL ELEMENTARY SCHOOL"**

WHEREAS, by virtue of Republic Act No. 9491, the Municipality of Naga, Cebu has been converted into a component City of Cebu Province, known as the City of Naga, Cebu;

WHEREAS, the Naga Central Elementary School with address at Barangay West Poblacion was established during the time when the City was still classified as a municipality;

WHEREAS, this administration deem it necessary to reflect the present name of the City in order to be consistent with the conversion status of this local government unit;

WHEREAS, pursuant to Section 13 (e) of the Local Government Code, the Local School Board of the City of Naga, Cebu in its Resolution No. 004-2013 recommends the renaming of the said school to City of Naga Central Elementary School;

WHEREAS, the National Historical Commission, through its Chairman - Dr. Maria Serena I. Diokno issued a letter dated 18 September 2013 interposing no objection to the proposed renaming of the said school;

NOW THEREFORE, Be it ordained by the Sangguniang Panlungsod of the City of Naga, Cebu that:

SECTION 1. DECLARATION. The Naga Central Elementary School is hereby renamed as the CITY OF NAGA CENTRAL ELEMENTARY SCHOOL.

SECTION 2. PROSPECTIVITY. The new name "City of Naga Central Elementary School" shall now appear in all future documents. Documents currently bearing the name "Naga Central Elementary School" shall the remain the same.

SECTION 3. INFORMATION DESSIMINATION. Copies of this Ordinance shall be furnished the Office of the City Mayor; Office of the Local School Board, City of Naga, Cebu; the Office of the Schools Division Superintendent, City of Naga Division (DepEd); the National Historical Commission of the Philippines; the Philippine Postal Service; the Office of the President, the Barangay concerned, and all other Departments and Offices of the City Government of Naga, Cebu, for their information, reference and file.

SECTION 4. REPEALING CLAUSE. All ordinances and resolutions, circulars, memoranda, rules and regulations or parts thereof, which are inconsistent with this Ordinance, are hereby repealed, amended or modified accordingly.


SECTION 5. SEPARABILITY CLAUSE. If any part, section, or provision of this ordinance shall be held invalid or unconstitutional, the other parts or sections not be affected thereof, and shall continue to take force and effect.

SECTION 6. EFFECTIVITY. This ordinance shall take effect immediately after fifteen (15) days of its publication in the newspaper of local circulation or after posting for fifteen (15) days at least in three conspicuous places within the city.




