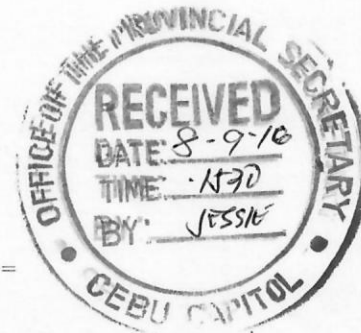

ORDINANCE NO. 2016-008

Hon. Pablo A. Abangan – Sponsor

AN ORDINANCE APPROVING THE CREATION OF NEW POSITIONS OF TWO (2) SECURITY AGENTS I AND ONE (1) CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD I OF THE CITY GOVERNMENT OF NAGA, CEBU

WHEREAS, Section 76 of the Local Government Code of 1991 clearly states that every local government unit is mandated to design and implement its own organizational structure and staffing pattern subject to its service requirements and financial capability as well as the standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, to be more responsive to the needs of the local constituents, ensure the safety and security of the city residents and facilitate efficient delivery of basic services to the public, there is a necessity to create new positions and adopt some adjustments in the organizational structure of the City Government of Naga, Cebu;

WHEREAS, the Local Chief Executive has requested this Sanggunian to enact an ordinance creating three new positions, to wit: two Security Agents I under the Office of the City Mayor, and a City Government Assistant Department Head I under the City Legal Office;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as “AN ORDINANCE APPROVING THE CREATION OF NEW POSITIONS OF TWO (2) SECURITY AGENTS I AND ONE (1) CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD OF THE CITY GOVERNMENT OF NAGA, CEBU”

SECTION 2. CREATION. There is hereby created the following positions to wit:

- a. Two (2) Security Agents I, Salary Grade 8, under the Office of the City Mayor
- b. One (1) City Government Assistant Department Head I, Salary Grade 23, under the City Legal Office

SECTION 3. ORGANIZATIONAL STRUCTURE. With the creation of the positions mentioned in Section 1, the organizational structure of the abovementioned offices is hereby amended.

SECTION 4. REPEALING CLAUSE. – All ordinances, resolutions, memoranda, orders and similar issuances, or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 5. SEPARABILITY CLAUSE – If, for any reason or reasons, any part or provision of this Ordinance is declared unconstitutional or invalid, other parts or provisions thereof not affected thereby shall continue to be in full force and effect.

SECTION 6. COPIES FURNISHED AND POSTING CLAUSE – Let copies of this Ordinance be furnished the Office of the City Mayor, the City Human Resource Management Office and other concerned offices for their information, reference and documentation.


SECTION 7. EFFECTIVITY. – This ordinance shall take effect immediately upon approval.
