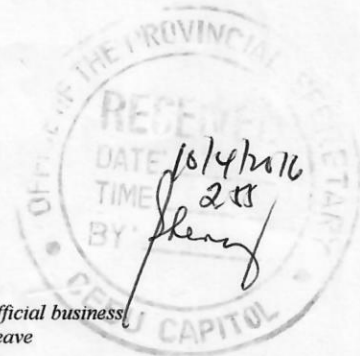

ORDINANCE NO. 2016-011

AN ORDINANCE NAMING THE MULTI-PURPOSE HALL A OF THE CITY HALL BUILDING AS VISION AND LEADERSHIP (VAL) 2020 HALL

WHEREAS, Chapter 2 of Section 13 (c) (5) of RA 7160 otherwise known as the Local Government Code of 1991 empowers the Sanggunians of component cities and municipalities to rename any public place or building owned by the local government units (LGUs) concerned within their respective territorial jurisdictions;

WHEREAS, the Vision and Leadership (VAL) 2020 is a long-term development plans and programs of the City Government of Naga conceptualized during the term of former Mayor Valdemar M. Chiong, the first local chief executive when this former coastal town became a component city of Cebu Province in 2007 by virtue of Republic Act No. 9491, the Charter of the City of Naga;

WHEREAS, it was the consensus of this Body to rename the multi-purpose hall A located on the ground floor of the two-storey City Hall building as VISION AND LEADERSHIP (VAL) 2020 Hall;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This ordinance shall be known: "AN ORDINANCE NAMING THE MULTI-PURPOSE HALL A OF THE CITY HALL BUILDING AS VISION AND LEADERSHIP (VAL) 2020 HALL.

SECTION 2. OFFICIAL NAME: VAL 2020 HALL, as its official name, will be used in all official transactions especially when events, meetings or any city-related activities are held at the aforementioned hall located on the ground floor of the City Hall building.

SECTION 3. SEPARABILITY CLAUSE – Should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.


SECTION 4. REPEALING CLAUSE – Any and all Ordinances or provisions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. COPIES FURNISHED CLAUSE – Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance and documentation.

SECTION 6. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval in accordance with law.


