ORDINANCE NO. 2017-002

AN ORDINANCE CREATING NEW POSITIONS IN THIS LOCAL GOVERNMENT UNIT AND ADOPTING NEW PLANTILLA OF PERSONNEL UNDER THE CITY HEALTH, CITY ENGINEER, CITY ENVIRONMENT AND NATURAL RESOURCES AND CITY PLANNING AND DEVELOPMENT COORDINATOR OFFICES

EXPLANATORY NOTE

The City Government of Naga deems it necessary to create new positions for inclusion in the plantilla of personnel so as to cope with the expanding scope of public services more particularly in the implementation of its environmental, infrastructure, social and health care programs.

These new positions include Medical Officer III, Dentist I, Radiologic Technologist I and Health Education and Promotion Officer I to be detailed at the City Health Office (CHO) for proper management of Vicente Mendiola Center for Health (VMCH); three (3) Engineers I and one Architect I for quality implementation of city-initiated projects through the Office of the City Engineer; two (2) Environment Management Specialist (I and II) at City Environment and Natural Resources Office (CENRO) for assistance in the operation of a treatment plant facility in Barangay Naalad and the programs and projects related to forest, forest land and coastal resources management; and one Project Development Officer I at City Planning and Development Coordinator (CPDC) Office for assistance in the formulation of city development plans particularly in social, economic, physical infrastructure and environment.

In view of the above-stated premises, this ordinance is hereby conceptualized.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This ordinance shall be known as: "AN ORDINANCE CREATING NEW POSITIONS IN THIS LOCAL GOVERNMENT UNIT (LGU) AND ADOPTING NEW PLANTILLA OF PERSONNEL UNDER THE CITY HEALTH, CITY ENGINEER, CITY ENVIRONMENT AND NATURAL RESOURCES AND CITY PLANNING AND DEVELOPMENT COORDINATOR OFFICES."

SECTION 2. CREATION. There is hereby creating the following positions, to wit:

SECTION 3. ORGANIZATIONAL STRUCTURE. With the creation of the positions mentioned in Section 2 hereof, the organizational structures of the above-stated offices are hereby amended.

SECTION 4. APPROPRIATION. The City Government of Naga shall appropriate the necessary funds in its annual budget to cover the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.

SECTION 5. SEPARABILITY CLAUSE. should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.


SECTION 6. REPEALING CLAUSE. Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 7. COPY FURNISHED. The Civil Service Commission, Office of the City Mayor, City Budget Office and the City Human Resources Management Office shall be furnished with copies of this Ordinance for their information and appropriate action.


SECTION 8. EFFECTIVITY – This ordinance shall take effect immediately upon approval.
