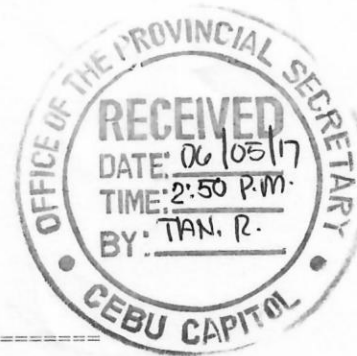

ORDINANCE NO. 2017- 007

AN ORDINANCE DECLARING THE WHOLE MONTH OF MAY 2017 AND EVERY YEAR THEREAFTER AS FAMILY MONTH IN THE CITY OF NAGA, CEBU

EXPLANATORY NOTE

The State, as explicitly provided in Article 2, Section 12 of the 1987 Constitution, recognizes the sanctity of family life, protects and strengthens the family as a basic autonomous social institution.

To give life to this constitutional principle, the City Government of Naga deems it essential to come up with special programs during the summer season to foster and strengthen family ties and inculcate traditional Filipino values.

These family strengthening programs are part and parcel of the Ten-Point Development Agenda of the present administration to ensure that all Nagahanons, especially the youth and children become educated, decent and responsible citizens in our society.

The City Government believes that strong families are the key to a prosperous society, where everyone has an individual obligation to contribute to its growth and development. This can be achieved best by fostering healthy and stable family units.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE - This ordinance shall be known as: AN ORDINANCE DECLARING THE WHOLE MONTH OF MAY 2017 AND EVERY YEAR THEREAFTER AS FAMILY MONTH IN THE CITY OF NAGA, CEBU.

SECTION 2. DECLARATION OF POLICY - The City of Naga, Cebu hereby declares its full commitment to pursue and formulate family strengthening programs as it recognizes the vital role of the family, being the basic unit of society, in the development and molding of the youth into educated, decent, caring and responsible citizens.

SECTION 3. CREATION OF THE CITY OF NAGA FAMILY COUNCIL (CNFC)
- To successfully implement these family strengthening programs, the CNFC is hereby created and shall be composed of the following:

- Co-Chairman : City Social Welfare and Development Officer

SECTION 4. – FUNCTIONS AND RESPONSIBILITIES – The CNFC shall perform the following functions and responsibilities;

- a. Formulate family strengthening and solidarity programs and projects and actively work for its development and sustainability;
- b. Ensure awareness of the importance of family as the foundation of the nation; and
- c. Formulate programs and related activities especially during the Family Month Celebration that foster and strengthen family ties such as but not limited to Movies at the Park, Family Got Talent, Pets Day, Circus at the Park, and Family Fun Run.

SECTION 4. – SECRETARIAT. Secretariat and Technical Working Group are hereby created and composed of the following: the City Mayor’s Office Representative, City Social Welfare and Development (CSWD) Representative, DepEd Representative, ABC Representative, City PIO, SK Federation President and SP Representative.

SECTION 5. – FUNDING. – Funding shall be appropriated for this purpose chargeable against the City’s Annual Budget.


SECTION 11. SEPARABILITY CLAUSE - If for any reason, any portion of this Ordinance be declared unconstitutional or invalid by a competent authority, its other provisions shall remain thereof.

SECTION 12. REPEALING CLAUSE – All other ordinances, rules and regulations or parts thereof which are in conflict with or inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.


SECTION 13. EFFECTIVITY - This Ordinance shall take effect upon its approval thereof.
