AN ORDINANCE OFFICIALLY NAMING GOVERNMENT-OWNED BUILDINGS AND FACILITIES OF THE CITY OF NAGA, CEBU

EXPLANATORY NOTE

Section 13 (c) (5) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename any other public place, or building within its territorial jurisdiction.

The City Government of Naga, Cebu has already owned a number of public buildings and facilities, which bear project names, but have not been officially named or identified following their completion.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as “AN ORDINANCE OFFICIALLY NAMING GOVERNMENT BUILDINGS AND FACILITIES OF THE CITY OF NAGA, CEBU.

SECTION 2. OFFICIAL NAME. The following public buildings and facilities enumerated below, with their respective descriptions and locations, shall bear the official names, viz:

SECTION 3. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of clear and visible signage for proper guidance and direction of the transacting public.

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


SECTION 5. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all government agencies/offices concerned for their information, reference, guidance, and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval in accordance with law.
