APPROPRIATION ORDINANCE NO. 2020-21

WHEREAS, subjected to deliberation by this Sanggunian is the proposed Supplemental Budget No. 02 for Calendar Year (CY) 2020 containing appropriation amounting to Forty-Six Million Eight Hundred Ninety-Two Thousand Forty-Seven Pesos (P46,892,047.00);

WHEREAS, the Statement of Funding Sources certified as correct by the Offices of the City Treasurer and City Accountant showed that the above-stated amount is available to cover the Statement of Supplemental Appropriation under the Special Account Bayanihan Grant to Cities and Municipalities (BGCM);

WHEREAS, the Committee on Finance, Budget and Ways and Means, chaired by Hon. Letecia F. Abangan, acknowledged the urgency and necessity of the approval of this proposed Appropriation Ordinance.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. APPROPRIATION - The amount of Forty-Six Million Eight Hundred Ninety-Two Thousand Forty-Seven Pesos (P46,892,047.00) is hereby appropriated for Supplemental Budget No. 02 for CY 2020 of the City Government of Naga, Cebu. *(Attached copies of Statement of Supplemental Appropriations show specific details as to the particulars/purpose, the implementing office, object of expenditures, AIP code, account code and amount).*

SECTION 2. CREATION OF SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) - Section 3.7 of Local Budget Circular No. 125 dated April 17, 2020 of the Department of Budget and Management (DBM) mandates the creation of a SAGF for the BGCM through an inclusion in the pertinent appropriation ordinance by the local sanggunian authorizing a supplemental budget covering the BGCM.

SECTION 3. USE OF FUNDS AND PURPOSE OF SAGF - the same Section 3.7 of the DBM Local Budget Circular provides that the use of the BGCM is subject to the usual local budgeting process, and that the purpose in the creation of the SAGF is "for easy monitoring/tracking of the utilization of the allocation of each city and municipality."

SECTION 5. APPROVAL - Supplemental Budget No. 02 for CY 2020 of the City of Naga, Cebu, containing appropriation in the amount of Forty-Six Million Eight Hundred Ninety-Two Thousand Forty-Seven Pesos (P46,892,047.00) is hereby **APPROVED**.


SECTION 6. SEPARABILITY CLAUSE - If for any reason, any section or provision of this Appropriation Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY - This Appropriation Ordinance shall take effect immediately upon its approval.


