APPROPRIATION ORDINANCE NO. 2017-SB-02

AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN MILLION SEVEN HUNDRED FIFTY-FOUR THOUSAND NINETY-SIX PESOS (P10,754,096.00) AS SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2017 OF THE CITY OF NAGA, CEBU

WHEREAS, subjected to deliberation by this Body is Supplemental Budget No. 02 for FY 2017 containing appropriation totaling TEN MILLION SEVEN HUNDRED FIFTY-FOUR THOUSAND NINETY-SIX PESOS (P10,754,096,00) intended to grant monetary incentive to all city officials, regular and casual employees of this local government unit (LGU) as contained in the Statement of Supplemental Appropriations hereto attached;

WHEREAS, the Statement of Funding Sources certified as correct by City Treasurer Anna Maria B. Gabilan and City Accountant Kelvin L. Ababa on December 04, 2017 showed that the above-stated amount is available to cover the Statement of Supplemental Appropriation under the General Fund - Proper generated from sources specified below:

General Fund-Proper	-	P10,394,096.00
Market Operation	-	P 210,000.00
Slaughterhouse Operation	-	P 150,000.00
Total	-	P10,754,096.00

WHEREAS, after a thorough deliberation and upon the recommendation of the concerned committee, this Sanggunian deemed it appropriate to approve this Supplemental Budget No. 2, so as to facilitate disbursement/payment of obligations for monetary incentive of all city officials, regular and casual employees of this LGU as stated in the Statement of Supplemental Appropriation;


NOW THEREFORE, Be it enacted by the Sangguniang Panlungsod of the City of Naga, Cebu, that:

SECTION 1. Supplemental Budget No. 02 for Calendar Year 2017 of the City of Naga, Cebu, containing appropriation in the amount of TEN MILLION SEVEN HUNDRED FIFTY FOUR THOUSAND NINETY-SIX PESOS (P10,754,096,00) to cover appropriation for monetary incentive of all city officials, regular and casual employees of the City Government of Naga, Cebu, as contained in the Statement of Supplemental Appropriations under the General Fund-Proper is hereby **APPROVED**.


SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon approval.


