APPROPRIATION ORDINANCE NO. 2018-SB-06

AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 06 FOR CALENDAR YEAR (CY) 2018 AND APPROPRIATING THE AMOUNT OF NINE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND SEVEN HUNDRED NINETY-THREE PESOS (P9,381,793.00)

WHEREAS, subjected to deliberation is the proposed Supplemental Budget No. 06 for CY 2018 containing appropriation totaling NINE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND SEVEN HUNDRED NINETY-THREE PESOS (P9,381,793.00).

WHEREAS, the Statement of Funding Sources certified as correct by the Offices of the City Treasurer and City Accountant showed that the above-stated amount is available to cover the Statement of Supplemental Appropriation, more detailed as follows, viz:

➤ General Fund – Proper	-	P9,021,793.00
➤ Market Operations	-	P 210,000.00
➤ Slaughterhouse Operations	-	<u>P 150,000.00</u>
Grand Total	-	P9,381,793.00

WHEREAS, the Committee on Finance, Budget and Ways and Means, chaired by Hon. Pablo A. Abangan, acknowledged the urgency and necessity of the approval of this proposed Appropriation Ordinance.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. APPROVAL. Supplemental Budget No. 06 for CY 2018 of the City of Naga, Cebu, containing appropriation in the amount of NINE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND SEVEN HUNDRED NINETY-THREE PESOS (P9,381,793.00) is hereby **APPROVED**.

The budget documents consisting of the following are incorporated herein and made as an integral part of this ordinance:

1. Transmittal Letter from the Office of the City Mayor
2. Local Budget Preparation Form No. 08 (Certified Statement of Funding Sources)
3. Local Budget Preparation Form No. 09 (Statement of Supplemental Appropriation)

SECTION 2. USE OF FUNDS. The amount of NINE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND SEVEN HUNDRED NINETY-THREE PESOS (P9,381,793.00) is hereby appropriated for Supplemental Budget No. 06 for CY 2018 of the City Government of Naga, Cebu. (Attached copies of Statement of Supplemental Appropriations show specific details as to the particulars/purpose, the implementing offices, objects of expenditures, account code and amount).

SECTION 3. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Appropriation Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.


SECTION 4. EFFECTIVITY. The provisions of this Appropriation Ordinance shall take effect immediately upon its approval in accordance with law.
