**APPROPRIATION ORDINANCE NO. 2022-05**

**Hon. Letecia F. Abangan - Sponsor**

*Chairperson, Committee on Finance, Budget and Ways and Means*

**WHEREAS**, subjected to deliberation is the proposed Supplemental Budget No. 05 for Calendar Year (CY) 2022 containing appropriation amounting to Twenty-Two Million Five Hundred Fifty-Five Thousand Pesos (₱22,555,000.00);

**WHEREAS**, the Statement of Funding Sources certified as correct by the Offices of the City Treasurer and City Accountant showed that the above-stated amount is available to cover the Statement of Supplemental Appropriation under the General Fund – Proper, Operations of Public Market and Operations of Slaughterhouse;

**WHEREAS**, the Committee on Finance, Budget and Ways and Means, chaired by Hon. Letecia F. Abangan, acknowledged the urgency and necessity of the approval of this proposed Appropriation Ordinance.

**BE IT ORDAINED**, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

**SECTION 1. APPROPRIATION** - The amount of Twenty-Two Million Five Hundred Fifty-Five Thousand Pesos (₱22,555,000.00) is hereby appropriated for Supplemental Budget No. 05 for CY 2022 of the City Government of Naga, Cebu. *[Attached copies of Statement of Supplemental Appropriations show specific details as to the particulars/purpose (Monetary Incentive; additional appropriation for overtime pay; additional appropriation – fuel & lubricants for the city’s service vehicles; additional appropriation – Repairs & Maintenance – Buildings & Other Structures; additional appropriation – Other MOOE Account; additional appropriation – Capital Outlay Accounts for the city’s various projects: Purchase of Land, ICT Equipment, Office Equipment, Furniture & Fixtures; Other Property, Plant & Equipment; Terminal Leave Benefits – Madonia Patiga; Child Placement Services/RRCY, the implementing offices (Mayor’s Office, Sangguniang Panlungsod, Administrator, Planning and Development Coordinator, Local Civil Registrar, General Services, Budget, Accounting, Treasury, Assessor, Information and Community Relations, Public Services, Agriculture, Veterinary, CENRO, Engineering, Health and Social Welfare Development), object of expenditures, AIP code, account code and amount].*

**SECTION 2. SUPPORTING DOCUMENTS** – Documents consisting of the following are incorporated herein and made as integral part of this Ordinance:

1. Transmittal Letter from the Office of the City Mayor;
2. Local Budget Preparation Form No. 08 (Certified Statement of Funding Sources); and
3. Local Budget Preparation Form No. 09 (Statement of Supplemental Appropriation)

**SECTION 3. APPROVAL** – Supplemental Budget No. 05 for CY 2022 of the City of Naga, Cebu, containing appropriation amounting to Twenty-Two Million Five Hundred Fifty-Five Thousand Pesos (P22,555,000.00) is hereby **APPROVED**.



**SECTION 5. EFFECTIVITY** – This Appropriation Ordinance shall take effect immediately upon approval.






