**APPROPRIATION ORDINANCE NO. 2022-07**

**APPROVAL OF THE ANNUAL BUDGET OF THE CITY OF NAGA, CEBU FOR FISCAL YEAR (FY) 2023 COVERING VARIOUS EXPENDITURES UNDER THE GENERAL FUND AND SPECIAL ACCOUNTS: MARKET OPERATION AND SLAUGHTERHOUSE OPERATION**

**WHEREAS**, the Local Finance Committee of the City Government of Naga, Cebu has certified as urgent a project income/receipts for FY 2023 from local and external sources of revenues in the total amount of ONE BILLION TWO HUNDRED NINETY-THREE MILLION PESOS (P1,293,000,000.00) per Certified Statement of Receipts hereto attached;

**WHEREAS**, based on the estimated income for FY 2023, the Office of the City Mayor submitted to this Sanggunian for approval of the proposed Annual Budget of the City Government of Naga, Cebu for FY 2023 covering the General Fund-Proper and the Special Accounts: Market Operation and Slaughterhouse Operation;

**WHEREAS**, after a careful and thorough review and deliberation on the proposed Annual Budget for FY 2023, in a series of sessions held, this Sanggunian found that the appropriations as contained in the Programmed Appropriation and Obligation by Object of Expenditures have conformed to the provisions and limitations of the General Appropriations Act and all other applicable Memorandum Circulars, Administrative Orders issued by proper authorities.

**NOW THEREFORE**, be it **ORDAINED**, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu that:

**SECTION 1. GENERAL FUND-PROPER APPROVAL.** – The Annual Budget for FY 2023 of the City of Naga, Cebu containing various appropriation items, detailed in the attached Programmed Appropriation and Obligation by Object of Expenditures classified under the GENERAL FUND-PROPER amounting to ONE BILLION TWO HUNDRED SEVENTY-FIVE MILLION PESOS (P1,275,000,000.00) is hereby **APPROVED**.

**SECTION 2. SPECIAL ACCOUNTS APPROVAL.** – The Annual Budget for FY 2023 of the City of Naga, Cebu containing various appropriation items, detailed in the attached Program Appropriations and Obligation by Object of Expenditures, classified under SPECIAL ACCOUNTS stated hereunder is hereby **APPROVED**.

- MARKET OPERATION FUND amounting to FOURTEEN MILLION PESOS (P14,000,000.00)
- SLAUGHTERHOUSE OPERATION FUND amounting to FOUR MILLION PESOS (P4,000,000.00)

**SECTION 3. SEPARABILITY CLAUSE.** – If for any reason, any section or provision of this Appropriation Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.


**SECTION 4. REPEALING CLAUSE.** – Any ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

**SECTION 5. EFFECTIVITY.** – This Appropriation Ordinance shall take effect on January 01, 2023.
