AN ORDINANCE SETTING THE FEES AND CHARGES FOR THE DIAGNOSTIC IMAGING EXAMINATIONS (X-RAY AND ULTRA SOUND) AT VICENTE MENDIOLA CENTER FOR HEALTH (VMCH) OF THE CITY OF NAGA, CEBU

EXPLANATORY NOTE

As embodied in Section 15 Article II of the Constitution, "the State shall protect and promote the right to health of the people and instill health consciousness among them." In addition, Section 11 Article XIII provides that: "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost."

To give substance and spirit to the above constitutional precepts, the City Government of Naga, Cebu has established its own one-stop health care facility - the Vicente Mendiola Center for Health (VMCH) with the primary objective of providing immediate, quality yet affordable health care services to the city residents.

It may be considered the newest LGU-run center for health in Cebu, yet the services of VMCH are not limited to the basic medical needs of its constituents because it provides the latest laboratory and diagnostic imaging examinations such as x-rays and ultrasounds.

This health care facility is a dream come true for all the Nagahanons as it forms a great part in living up to its distinction as one of the most livable, health-conscious and competitive cities in the country today.

In view of the foregoing, this ordinance is hereby conceptualized.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE - This ordinance shall be known: "AN ORDINANCE SETTING THE FEES AND CHARGES FOR THE DIAGNOSTIC IMAGING EXAMINATIONS (X-RAY AND ULTRA SOUND) AT VICENTE MENDIOLA CENTER (VMCH) OF THE CITY OF NAGA, CEBU."

SECTION 2. DEFINITION OF TERMS - as used in this ordinance, the following terms are defined as follows:

- (a) **CHARGES** – refers to pecuniary liability, as fees against persons, business entities involved in health, provision both in government and in the private sector.
- (b) **FEE** – a charge fixed by law/ordinance relevant to the use of hospital facilities
- (c) **SERVICES** – the duties, work or functions performed, discharged by hospital employees or officers.
- (d) **REVENUE** – includes fees and charges that a state or a political subdivision collects & receives into the treasury for public purposes.

SECTION 5. PROCEDURES - a.) Payments are made before examination is performed; and b.) Patients must pay directly to the City Treasurer's Office (CTO) at City Hall. Receipt shall be presented to the VMCH laboratory section for the service. The CTO shall assign an office staff to receive payments at the VMCH counter during weekends and/or holidays. The payments collected shall be turned over to the CTO on the first subsequent working day.

SECTION 6. SPECIAL DISCOUNTS FOR CITY RESIDENTS AND SENIOR CITIZENS
- Bona fide City of Naga residents and senior citizens shall be entitled to a twenty percent (20%) discount for availing of the services of VMCH upon presentation of valid identification (ID) cards such as but limited only to Naga-issued ID System, voters or Commission on Elections (Comelec) ID and senior citizens ID.

SECTION 7. SEPARABILITY CLAUSE - should any provisions of the Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.


SECTION 8. REPEALING CLAUSE – Any ordinance contrary to or inconsistent with this Ordinance are hereby repealed or considered modified.

SECTION 9. COPIES FURNISHED CLAUSE - Let copies of this Ordinance be furnished the Office of the City Mayor, the City Health Office and all other concerned offices for their information, guidance and documentation.

SECTION 10. EFFECTIVITY – This ordinance shall take effect ten (10) days after its approval and posting in at least two (2) conspicuous public places.


