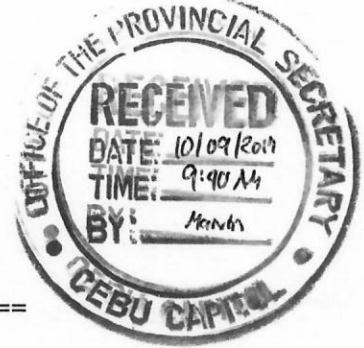

**ORDINANCE NO. 2017- 019**

**AN ORDINANCE ESTABLISHING THE OPERATION OF KAYAK, PADDLEBOARD AND ZIPLINE ACTIVITIES IN THE CITY OF NAGA, CEBU AND FIXING THE RATES FOR THE USE THEREOF**

**EXPLANATORY NOTE**

The City Government of Naga, Cebu has observed the popularity of ziplines, paddleboards and kayaks as an adventure and outdoors activity.

With the natural terrain and coastline view of the city, the City Government sees this as an income generating prospect with dual purpose - for outdoor entertainment of its constituents and additional revenues to the city.

In view of the above premises, the city has caused for the installation of a zipline in the lighthouse tower of the baywalk area and has planned for kayak and paddleboard activities in its bay waters.

To promote a safe environment and ensure proper operation of these recreational activities, the City Government cites the need to set forth the usage rates for these activities to support the upkeep and maintenance of its watersports facilities, and as an added income to the city.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga Cebu, in session assembled that:

**SECTION 1. TITLE.** This Ordinance shall be known as “AN ORDINANCE ESTABLISHING THE OPERATION OF KAYAK, PADDLEBOARD AND ZIPLINE ACTIVITIES IN THE CITY OF NAGA, CEBU AND FIXING THE RATES FOR THE USE THEREOF.”

**SECTION 2. RATES.** The rates of these activities shall be set as follows:

- a. Zipline
 

Adults	-----	₱100.00
Children	-----	₱ 80.00
  
- b. Kayak Rental Rates
 

30 minutes	-----	₱100.00
1 Hour	-----	₱150.00

c. Paddleboard		
30 inutes	-----	₱100.00
1 Hour	-----	₱150.00

City residents are entitled to twenty percent (20%) discount upon presentation of City of Naga-issued Identification Cards pursuant to Ordinance No. 2017-12, entitled: AN ORDINANCE ESTABLISHING THE CITY OF NAGA, CEBU STANDARD IDENTIFICATION SYSTEM (CN-SIDS).

**SECTION 3. FORMULATION OF IMPLEMENTING RULES AND REGULATIONS.** Within ten (10) days from the promulgation of this Ordinance, the City Engineering Office together with the City Disaster Risk Reduction and Management Council shall formulate and issue the appropriate rules and regulations for the efficient and safe implementation of the kayak, paddleboard and zipline activities.

**SECTION 4. WATERSPORTS AND ZIPLINE MANAGEMENT TEAM.** There shall be created a Watersports and Zipline Management Team, the composition and functions of which shall be determined in the implementing rules and regulations (IRR). The team shall be responsible for the supervision and management of the watersports and zipline activities; monitor and advise the City Mayor through the City Administrator on all matters affecting the operation and management of said activities; cause the effective implementation of the IRR; ensure maintenance and coordination to ensure a safe operation of watersports and zipline activities.

**SECTION 5. BUDGET APPROPRIATION.** To effectively carry out the implementation of this Ordinance, the city shall include in its annual budget sufficient funds for this purpose subject to the usual auditing rules and regulations.

**SECTION 6. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


**SECTION 7. REPEALING CLAUSE.** All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

**SECTION 8. COPIES FURNISHED CLAUSE.** Let copies of this Ordinance be furnished to all offices concerned for their formation, reference, guidance, and documentation.

**SECTION 9. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval in accordance with law.


