### AN ORDINANCE INSTITUTIONALIZING THE NAGA AKONG GARBO (NAGa) - OUR SUSTAINABLE CEBU PROGRAM

#### EXPLANATORY NOTE

The Our Cebu Program is a development program born out of collaboration and Cebuanos' desire to put and maintain Cebu, Philippines on the map as an ideal place to live, work, play, invest, and do business.

Initiated by the Cebu Provincial Government and the Ramon Aboitiz Foundation Inc. (RAFI) and institutionalized through Provincial Ordinance No. 2013-013, this program is implemented throughout the 52 component cities and municipalities of Cebu. It is about helping each city and town in the province put into play the seven dimensions of sustainable development.

This comprehensive integrated development program aims to:

- strengthen the governance systems and structures of local government units;
- improve livability and access to basic services;
- protect the natural environment;
- promote Cebu's eco-tourism; and
- develop sense of pride among Cebuanos through understanding of their culture and heritage

The Our Cebu Program has created the Livable Scorecard System, a tool in the assessment and evaluation process, which is used to measure the performance the local government units of Cebu using the following attributes, namely: Green, Livability, Inclusiveness and Competitiveness, Historical and Cultural, and Resiliency and Governance. It is implemented through the collaboration of a multi-sectoral and multi-disciplinary panel of evaluators from different regional government agencies and private sector.

Thus, the City Government of Naga, Cebu believes in the vision of the Our Cebu Program, as it provides for the blueprint that will enable the city to achieve its long term goal for sustainable development.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga Cebu, in session assembled that:

TITLE. This ordinance SECTION 1. shall be called as an "ORDINANCE INSTITUTIONALIZING THE NAGA AKONG GARBO (NAGa) - OUR SUSTAINABLE CEBU PROGRAM."

SECTION 2. MAINSTREAMING NAGa - OUR SUSTAINABLE CEBU PROGRAM. The NAGa - Our Sustainable Cebu Framework includes the following standards and components on Livability, Green Attribute, Inclusiveness and Competitiveness and Governance which are being mainstreamed and applied at the respective departments and offices of the City Government.

SECTION 3. ORGANIZATIONAL STRUCTURE. The NAGa - Our Sustainable Cebu Program shall be lodged at the Office of the City Mayor through the Special Programs and Projects Office (SPPO) headed by a manager who will ensure that the goals and objectives of the NAGa - Our Sustainable Cebu Program are efficiently and effectively delivered. To assist the SPPO manager will be City Hall staff assigned to the office who shall perform assigned tasks either on technical operations or administrative mobilization.

SECTION 4. DUTIES AND RESPONSIBILITIES. The SPPO shall perform the duties and responsibilities in relation to program management and coordination, program/project implementation and monitoring, advocacy, promotion and sustainability of the City Government's special programs and projects and the formulation and pre-implementation of new programs and projects that may be identified by the City Government.

SECTION 5. FUNDS REQUIREMENT. An appropriation of Three Million Nine Hundred Thousand Pesos (PhP3,900,000.00) shall be appropriated annually by the City Government. The appropriation amount shall be increased as the need arises subject to the approval of the City Mayor and will be incorporated in any of the supplemental budgets of the City Government for any given year and the usual government accounting and auditing requirements.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 8. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their formation, reference, guidance, and documentation.

SECTION 9. EFFECTIVITY. This Ordinance shall take effect immediately upon approval in accordance with law.
