### ORDINANCE NO. 2018-006

AN ORDINANCE OFFICIALLY NAMING ALL EXISTING STREETS, BARANGAY ROADS AND ROAD ARTERIES IN BARANGAY INOBURAN, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO INOBURAN FISH PORT, AS SALVADOR A. MAHUSAY STREET; 2. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO RAILWAY, AS LUIS V. BALILI STREET; 3. AT REAR SIDE OF LANGTAD ELEMENTARY SCHOOL, AS REGINO G. BARICUATRO STREET; 4. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO REGINO G. BARICUATRO STREET (AT REAR SIDE OF LANGTAD ELEMENTARY SCHOOL), AS PEDRO J. CANTILLAS STREET; 5. FROM REGINO G. BARICUATRO STREET (ROAD CONTINUATION), AS CRISPINO B. LIBOR STREET; 6. THE ROAD TRAVERSING PUROK ATIS, AS EDDIE CANQUE PARADELA STREET AND; 7. FROM JUNCTION INOBURAN ROAD TO PUROK ATIS ROAD, AS FERDINAND M. CHIONG STREET

#### **EXPLANATORY NOTE**

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Inoburan passed Resolution No. 18, series of 2017 and dated June 21, 2017 highly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of the identified streets, roads and road arteries as mentioned in the above title of this ordinance.

The Sangguniang Barangay deemed it proper to name the streets in honor of the kind hearted private individuals whose families donated their lots for public use and to local leaders who had served with dedication, professionalism and utmost sincerity during their incumbencies. Their names appeared below as follows:

SALVADOR ABELLANIDA MAHUSAY - A farmer or "magtutubo" from Negros Occidental, he was remembered to be a loving, responsible and hard working father to his family. Though, he died at a young age of 42, his life served as an inspiration to his two daughters who have successfully established their own businesses.

The Mahusay family acquired the property where the existing road traverses towards Inoburan fish port and decided to donate a portion of it for public use provided that the street be named in honor of their late father.

• ENGR. LUIS VARQUEZ BALILI – He was an outstanding professional in the field of engineering. Apart from topping the Mechanical Engineering Board examination in 1960, Engr. Balili was also a licensed Electrical Engineer.

He was a professor of the then Cebu Institute of Technology (now CIT-University) at N. Bacalso Highway in Cebu City from 1961-1970 and became Regional Equipment Engineer of the Department of Public Works and Highways from 1971 to 1980.

Engr. Balili also served as board examiner of the Professional Regulation Commission (PRC)

from 1980-1990. He died at the age of 68.

• PEDRO JABONILLO CANTILLAS – known as "Pedoy" by his friends and associates, he was acknowledged as a modest person whose only ambition in life was to raise his family with dignity through hard work and dedication.

His commitment to help others led him to join politics where he served as Municipal Councilor of Naga, Cebu for 12 years – first as a councilor for two consecutive terms from 1957

to 1964 and then his last term from 1968 to 1972.

Notable among his achievements was the installation of artesian wells in low-lying and upland barangays, so residents can have access to clean potable water instead of fetching unsafe water from the river and hallow wells or *tabay*.

Seeing the importance of education to Nagahanons, Cantillas initiated the construction of school buildings in the mountain barangays through the assistance of the Cebu Provincial Government.

- REGINO GENODIALA BARICUATRO. A full-blooded Nagahanon who was described as a hard working father of nine children four sons and five daughters. He was a loyal employee of APO Cement Corporation for 40 long years.
- CRISPINO B. LIBOR He was one of the grandsons of the late Don Rufo T. Libor, a prominent family during the pre-world war II era. A true-blue Nagahanon, Libor excelled in his educational attainment and private employment in Bohol and Cebu until his retirement in 1992. He passed away in August 2007, leaving behind a family eight children in Barangay Inoburan.
- EDDIE CANQUE PARADELA He was born to a big family and was adopted by spouses David Paradela and Corazon Canque. He and his family migrated to the United States of America in 1967. A philanthropist by heart, Paradela decided to donate a portion of his property for the opening of a barangay road in Inoburan.
- FERDINAND MENDIOLA CHIONG Nagahanons tasted a new brand of leadership when he was elected mayor of the then Municipality of Naga, Cebu in 1998, whose local political landscape was formerly dominated by his predecessor, Mayor Paulino S. Ong.

Popularly known as Enan, he left a distinctive mark in the hearts of every Nagahanon as the prime mover of the Naga Cityhood. His vision for Naga ultimately came to fruition when the Supreme Court affirmed with finality the constitutionality of Naga's cityhood in 2011, more than four years of tedious legal battle.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) SALVADOR A. MAHUSAY STREET;
- b) LUIS V. BALILI STREET;
- c) PEDRO J. CANTILLAS STREET;
- d) REGINO G. BARICUATRO STREET;
- e) CRISPINO B. LIBOR STREET:
- f) EDDIE C. PARADELA STREET; AND
- g) FERDINAND M. CHIONG STREET

in Barangay Inoburan, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Salvador A. Mahusay Street, Luis V. Balili Street, Pedro J. Cantillas Street, Regino G. Baricuatro Street, Crispino B. Libor Street, Eddie C. Paradela Street, and Ferdinand M. Chiong Street in Barangay Inoburan will be used as the official street names in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above mentioned streets and roads.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of clear and visible street signage for proper guidance and direction of pedestrians and the commuting public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval in accordance with law.
