**ORDINANCE NO. 2018-016**

**Hon. Scott Juvenal A. Chiong - Sponsor**

*SP Committee Chairman on Barangay Affairs; Infrastructure and Public Works*

**AN ORDINANCE OFFICIALLY NAMING ALL STREETS, BARANGAY ROADS, AND ROAD ARTERIES IN THE AREA OF JURISDICTION OF BARANGAY INAYAGAN, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM BARANGAY HALL GOING TO SITIO STO. NIÑO AS ACACIA STREET; 2. FROM PUROK BAYONG CENTRO, SITIO UPPER BAYONG TO PUROK RIVERSIDE, SITIO UPPER BAYONG AS BAYONG STREET; 3. FROM PUROK SABIN, SITIO STO. NIÑO TO PUROK STA. FILOMENA, SITIO ESTACA AS STO. NIÑO STREET; 4. FROM PUROK TANGASAN, SITIO STO. NIÑO GOING TO SITIO PANGILATAN AS PANGILATAN STREET; 5. FROM PUROK NATIONAL HIGHWAY, SITIO CENTRAL II TO SITIO SAN JUAN AS JUDGE RICARDO LARUMBE STREET AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF**

**EXPLANATORY NOTE**

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Inayagan passed Resolution No. 18 - 08, series of 2018 and dated June 4, 2018 strongly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of identified streets, barangay roads and road arteries as mentioned in the above title of this proposed ordinance.

The above-named streets have been remarkable to the people of Barangay Inayagan as follows: ACACIA trees have existed for many years in the place and serve as a landmark and terminal area bound for Cebu City and vice versa; BAYONG trees also have incidentally grown in the area and become useful for building nipa houses; STO. NIÑO has been instrumental to the former village chief Sabin Cabrana in the year 1960's and 1970's who had a great contribution to the construction of the chapel in Sitio Sto. Niño; PANGILATAN derived from Cebuano word "kilat" which means lightning. The area is located at the highest peak in the barangay and that lightning is very visible during rainy season.

Moreover, Barangay Council members and residents also unanimously agreed in a public hearing to name the National Highway junction of Sitio Central II to San Juan as Judge Ricardo Larumbe Street to give honor and recognition for his great contributions to Barangay Inayagan.

Thus, the Sangguniang Panlungsod deemed it proper to recognize the significance of the historical landmarks in Barangay Inayagan and give honor to individuals who, during their stints as public servant, have contributed to the socio-economic development and political landscape of the City of Naga, Cebu.

**BE IT ORDAINED**, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

**SECTION 1. TITLE.** This Ordinance shall be known as the official naming of:

- a) ACACIA STREET;
  - b) BAYONG STREET;
  - c) STO. NINO STREET;
  - d) PANGILATAN STREET AND
  - e) JUDGE RICARDO LARUMBE STREET
- in Barangay Inayagan, City of Naga, Cebu.

**SECTION 2. OFFICIAL NAME.** Acacia Street, Bayong Street, Sto. Nino Street, Pangilatan Street and Judge Ricardo Larumbe Street in Barangay Inayagan will be used as the official street names in all official transactions in the City of Naga, Cebu.

**SECTION 3. COVERAGE.** For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above mentioned Streets.

**SECTION 4. FUNDS AND IMPLEMENTATION.** The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians and the riding public.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


**SECTION 6. REPEALING CLAUSE.** All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

**SECTION 7. COPIES FURNISHED CLAUSE.** Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.


**SECTION 8. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval in accordance with law.


