## **ORDINANCE NO. 2018-017**

AN ORDINANCE OFFICIALLY NAMING ALL STREETS, BARANGAY ROADS, AND ROAD ARTERIES IN THE AREA OF JURISDICTION OF BARANGAY LANGTAD, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO PUROK DITA AS DELFIN PANILAGAO PAUNIL STREET; 2. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO PUROK SEASIDE I AS CRISANTA LIBOR SEÑOR STREET; 3. FROM N. BACALSO SOUTH NATIONAL HIGHWAY TO PLACIDO L. SEÑOR NATIONAL HIGH SCHOOL AS PLACIDO LIBOR SEÑOR STREET; AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

## **EXPLANATORY NOTE**

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Langtad passed Resolution No. 011-A, series of 2018 dated March 7, 2018 highly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of identified streets, barangay roads and road arteries as mentioned in the above title of this proposed ordinance.

The above-named personalities have greatly contributed to the development and progress of Barangay Langtad specified below, to wit:

• **DELFIN "MANONG DELFIN" PANILAGAO PAUNIL** was a Tenyente del Barrio in the year 1968 to 1986. In his years of service, he imposed honest and effective governance to promote peace and order and cleanliness in the barangay. He also organized livelihood programs to uplift the living conditions of the village residents.

Known for his dedication and commitment in serving the community, Mr. Paunil was acknowledged as the one responsible for the opening of an access road leading towards the highland area, which is now an existing barangay road going to Barangay Bairan.

• CRISANTA LIBOR SEÑOR was the heir of the landed spouses Rufo Libor and Teodora Gabriana. In collaboration with his husband Pastor Señor, they managed well their property as well as their fishing and farming businesses, their main sources of livelihood to support their children.

Her children and grandchildren decided to name the existing road that they donated in

honor of Mrs. Señor's name for her good deeds.

 PLACIDO "MANONG EDONG" LIBOR SEÑOR served as the village chief of Langtad and barangay kagawad from 1970 to 1987. He was recognized for his invaluable service and philanthropic outlook.

Mr. Libor was acknowledged for donating a total of 4,161 square meters of his property for the construction of a Barangay High School. His legacy was continued by his heirs who

donated an additional lot for the improvement of the school facilities.

Through a resolution, Langtad Barangay High School was renamed to Placido L. Señor Memorial National High School to give honor for his benevolence.

Thus, the Sangguniang Panlungsod deemed it proper to recognize and give honor to individuals who have greatly contributed to the socio-economic development and political landscape of the City Of Naga, Cebu.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) DELFIN PANILAGAO PAUNIL STREET;
- b) CRISANTA LIBOR SEÑOR STREET AND
- c) PLACIDO LIBOR SEÑOR STREET
- in Barangay Langtad, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Delfin Panilagao Paunil Street, Crisanta Libor Señor Street and Placido Libor Señor Street in Barangay Langtad will be used as the official street name in all official transactions in the City of Naga, Cebu.

- **SECTION 3. COVERAGE.** For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above mentioned streets.
- **SECTION 4. FUNDS AND IMPLEMENTATION.** The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians and the riding public.
- **SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.
- **SECTION 6. REPEALING CLAUSE.** All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.
- **SECTION 7. COPIES FURNISHED CLAUSE.** Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.
- **SECTION 8. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval in accordance with law.
