**ORDINANCE NO. 2018-020**

**AN ORDINANCE ESTABLISHING THE DEPARTMENT OF PUBLIC SERVICES (DPS) IN THE CITY OF NAGA, CEBU, PROVIDING FOR ITS FUNCTIONS, PERSONNEL AND APPROPRIATION THEREOF AND FOR OTHER PURPOSES**

**EXPLANATORY NOTE**

Republic Act 9491 otherwise known as “An Act Converting the Municipality of Naga in the Province of Cebu into a component city to be known as The City of Naga,” provides for the creation of offices in order to ensure efficiency and effectiveness in the implementation of plans, programs and activities of this local government unit (LGU).

Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 mandates LGUs to be self-reliant and shall continue exercising the powers and discharging the duties, functions and responsibilities currently vested upon them for efficient and effective provision of the basic services and facilities to the public.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod (SP) of the City of Naga, Cebu, in a session duly assembled, that:

**SECTION 1. TITLE.** This ordinance shall be known as the “ESTABLISHMENT OF THE DEPARTMENT OF PUBLIC SERVICES IN THE CITY OF NAGA, CEBU, PROVIDING FOR ITS FUNCTIONS, PERSONNEL AND APPROPRIATION THEREOF AND FOR OTHER PURPOSES.”

**SECTION 2. CREATION.** In relation to the establishment of the DPS, there is hereby the creation of the following positions, viz:

**SECTION 3. FUNCTIONS OF THE DPS.** The DPS is mandated to perform the following functions enumerated below pursuant to Section 17 (Basic Services & Facilities) of RA 7160 or the Local Government Code of 1991, viz:

- Intensify basic services pertaining to cleaning of streets and declogging of drainage, esteros and canals;
- Installation and maintenance of street lightings and other similar matters related to public works and services; and
- Perform such other duties and functions and exercise such other powers as provided for under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and those that are prescribed by law or ordinance.

**SECTION 4. ORGANIZATIONAL STRUCTURE.** With the creation of the positions mentioned in Section 2 hereof, the existing organizational structures of the above-stated office are hereby amended or modified accordingly.

**SECTION 5. SANGGUNIANG PANLUNGSOD CONCURRENCE.** Pursuant to the Provision of R.A 7160 otherwise known as the Local Government Code of 1991 and Civil Service Rules and Regulations, the appointment of the City Government Department Head I shall be subject to the concurrence of the SP.

**SECTION 6. APPROPRIATION.** The City Government of Naga, Cebu shall appropriate the necessary funds in its annual budget to cover the operations of the DPS including the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.

**SECTION 7. SEPARABILITY CLAUSE.** should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.

**SECTION 8. REPEALING CLAUSE.** Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

**SECTION 9. COPY FURNISHED.** The Civil Service Commission, Office of the City Mayor, City Budget Office and the City Human Resources Management Office shall be furnished with copies of this Ordinance for their information, reference, documentation and appropriate action.

**SECTION 10. EFFECTIVITY.** This ordinance shall take effect immediately upon approval in accordance with law.


