AN ORDINANCE CREATING 21 NEW POSITIONS IN THIS LOCAL GOVERNMENT UNIT IN THE OFFICES OF THE CITY MAYOR, CITY PLANNING AND DEVELOPMENT COORDINATOR, CITY ASSESSOR, CITY BUDGET, CITY HEALTH, CITY SOCIAL WELFARE AND DEVELOPMENT, MAINTENANCE OF SLAUGHTERHOUSE, CITY INFORMATION OFFICE, CITY ENVIRONMENT AND NATURAL RESOURCES, GENERAL SERVICES AND DEPARTMENT OF PUBLIC SERVICES

EXPLANATORY NOTE

The City Government of Naga, Cebu considers it necessary to create new positions for inclusion in the plantilla of personnel to improve efficiency in the delivery of public services to its constituents.

These new positions, totaling 21, will be under the 11 above-stated City Government offices, which include among others four (4) Administrative Aide I (Utility Worker I), one (1) Administrative Aide VI (Data Controller I), one (1) Administrative Aide III (Utility Worker II), one (1) Administrative Officer IV (Administrative Officer II), two (2) Security Agent I [Confidential Staff], two (2) Draftsman II, four (4) Nurse I, three (3) Social Welfare Officer I, two (2) Meat Inspector I, and one (1) Environment Management Researcher.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE – This ordinance shall be known as "AN ORDINANCE CREATING 21 NEW POSITIONS IN THIS LOCAL GOVERNMENT UNIT IN THE OFFICES OF THE CITY MAYOR, CITY PLANNING AND DEVELOPMENT COORDINATOR, CITY ASSESSOR, CITY HEALTH, CITY SOCIAL WELFARE AND DEVELOPMENT, MAINTENANCE OF SLAUGHTERHOUSE, CITY INFORMATION OFFICE, CITY ENVIRONMENT AND NATURAL RESOURCES, GENERAL SERVICES AND DEPARTMENT OF PUBLIC SERVICES."

SECTION 2. CREATION. There is hereby creating the following positions with the corresponding offices, item numbers and salary grades specified herein, to wit:

SECTION 3. ORGANIZATIONAL STRUCTURE. With the creation of the positions mentioned in Section 2 hereof, the organizational structures of the above-stated offices are hereby amended.

SECTION 4. APPROPRIATION. The City Government of Naga, Cebu shall appropriate the necessary funds in its annual budget to cover the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.

SECTION 5. SEPARABILITY CLAUSE. should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.


SECTION 6. REPEALING CLAUSE. Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 7. COPY FURNISHED. The Civil Service Commission, Office of the City Mayor, City Budget Office and the City Human Resources Management Office shall be furnished copies of this Ordinance for their information, reference, documentation and appropriate action.

SECTION 8. EFFECTIVITY – This ordinance shall take effect immediately upon approval in accordance with law.


