**AN ORDINANCE APPROVING THE GRANT OF FINANCIAL ASSISTANCE TO INTERNALLY DISPLACED PERSONS (IDPs) AFFECTED BY THE SEPTEMBER 20, 2018 LANDSLIDE IN BARANGAY TINAAAN, CITY OF NAGA, CEBU**

**EXPLANATORY NOTE**

This Sanggunian passed Resolution No. 001-A-2018 declaring the entire City of Naga under a state of calamity following a massive landslide on September 20, 2018 in Barangay Tinaan that resulted in the death of more than 70 persons and the displacement of close to 2,000 families.

The City Government of Naga has deemed it necessary to grant financial aid to the IDPs especially those whose residential houses have been included in the delineated critical zones and other Mines and Geosciences Bureau (MGB)-identified critical areas.

Thus, this administration has come up with a financial plan with a total program cost of FIFTY-TWO MILLION ONE HUNDRED THOUSAND PESOS (P52,100,000.00) chargeable against Local Disaster Risk Reduction and Management Fund (LDRRMF) 2018, LDRRMF 2017, Quick Response Fund, Appropriation Ordinance 2018-Supplemental Budget-05 and part of cash donations for landslide victims.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

**SECTION 1. TITLE** – This ordinance shall be known as "AN ORDINANCE APPROVING THE GRANT OF FINANCIAL ASSISTANCE TO INTERNALLY DISPLACED PERSONS (IDPs) AFFECTED BY THE SEPTEMBER 20, 2018 LANDSLIDE IN BARANGAY TINAAAN, CITY OF NAGA, CEBU.

**SECTION 2. FINANCIAL PLAN.** There is hereby a formulation of a financial plan for monetary assistance of the IDPs whose residential houses are either totally damaged or partially destroyed by the landslide (copy is hereto attached), more detailed as follows:

2. Some of the beneficiaries may choose Option 3 (Gawad Kalinga Site and Apo Cemex lot for donation). Thus, additional possible cost for the construction of an estimated 150 houses is specified here, viz:

**SECTION 3. FUNDING SOURCES.** To fund the above-stated humanitarian financial assistance, this local government unit (LGU) has to tap the following funding sources, to wit:

- a. DRRM Fund 2018
- b. DRRM Fund 2017
- c. Quick Response Fund
- d. Donations Account via Appropriation Ordinance 2018-SB-05 dated October 3, 2018
- e. Part of cash donations for landslide victims


**SECTION 4. SEPARABILITY CLAUSE.** should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.

**SECTION 5. REPEALING CLAUSE.** Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.


**SECTION 6. EFFECTIVITY** – This ordinance shall take effect immediately upon approval in accordance with law.
