AN ORDINANCE OFFICIALLY NAMING AND CHANGING THE STREETS, BARANGAY ROADS AND ROAD ARTERIES WITHIN THE JURISDICTION OF BARANGAY SOUTH POBLACION, CITY OF NAGA, CEBU FROM PRYCE GAS STREET PUROK 2 TALONG TO PUROK BUYO 2 LAWIS AS EUSEO M. VILLARINO STREET, AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of South Poblacion passed Resolution No. 28, series of 2017 dated June 15, 2017 strongly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of streets, barangay roads and road arteries from Pryce Gas Street Purok Talong 2 to Purok Buyo 2 Lawis as Euseo M. Villarino Street.

The Sangguniang Barangay deemed it appropriate to name the street in honor of the late Euseo M. Villarino, whom many considered as the longest serving village chief of Barangay South Poblacion, spanning for 20 years, during the time of President Ferdinand Marcos until the famous EDSA Revolution.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of **EUSEO M. VILLARINO STREET** in Barangay South Poblacion, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Euseo M. Villarino Street will be used as the official street name in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of Euseo M. Villarino Street.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians and the riding public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.


SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval in accordance with law.
