ORDINANCE NO. 2019-01

SP Committee Chairman on Barangay Affairs

OFFICIALLY NAMING THE STREETS, BARANGAY ROADS, AND ROAD ARTERIES IN THE AREA OF JURISDICTION OF BARANGAY BALIRONG, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM NAGA-TOLEDO NATIONAL ROAD TOWARDS PROPER A1 AS FLORA DAYRIT STREET; 2. FROM JUNCTION FLORA DAYRIT STREET TOWARDS PUROK PANAS-PUNOD AS SEÑOR SAN VICENTE FERRER STREET; 3. FROM JUNCTION FLORA DAYRIT STREET TOWARDS PUROK SIEN AS SEÑOR STO. NIÑO STREET; 4. FROM JUNCTION FLORA DAYRIT TOWARDS PUROK PANDAYAN AS FATIMA STREET; AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Balirong passed Resolution No. 051-18, series of 2018 dated September 21, 2018, strongly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of identified streets, barangay roads and road arteries as mentioned in the above title of this proposed ordinance.

In a public hearing, Barangay officials and residents reached a consensus to name the street covering the Naga-Toledo National Road to Proper A1 as Flora Dayrit, owner of Hacienda Dayrit, an estate whose length and breadth spread to the neighboring villages of Alpaco, Lutac and Tagjaguimit. Dayrit made a remarkable contribution in Balirong for donating a portion of her property as a site where Balirong Elementary School currently stands.

The Hacienda Dayrit was subdivided under the Land Reform Program of the Department of Agrarian Reform (DAR) in 1990's. Despite the management opposition to the order of (DAR), all the beneficiary farmers of the said hacienda received their respective Certificate of Land Ownership Award (CLOA).

In the same public hearing, barangay leaders and residents also unanimously agreed to designate the abovementioned streets after the name of their most revered patron saints in the communities, namely: SEÑOR SAN VICENTE FERRER, SEÑOR STO. NIÑO, AND FATIMA.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) FLORA DAYRIT STREET;
 - b) SEÑOR SAN VICENTE FERRER STREET;
 - c) SEÑOR STO. NIÑO STREET; AND
 - d) FATIMA STREET
- in Barangay Balirong, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Flora Dayrit Street, Señor San Vicente Ferrer Street, Señor Sto. Niño Street and Fatima Street in Barangay Balirong will be used as the official street names in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above-mentioned streets.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signages for proper guidance and direction of pedestrians, motorists and the riding public.

SECTION 5. SEPARABILITY CLAUSE. Should any provisions hereof be declared illegal or unconstitutional by any court of competent jurisdiction, those provisions not so declared shall remain valid and in full force and effect.


SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval in accordance with law.


