OFFICIALLY NAMING THE NEWLY IDENTIFIED ROAD IN BARANGAY MAYANA, CITY OF NAGA, CEBU COVERING PUROK MANGGA II, PUROK CERIS LEADING TO BARANGAY TAGJAGUIMIT AS SANTIAGO ALGABRE STREET, AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Mayana passed Resolution No. 070, series of 2018 dated March 4, 2018 strongly endorsing to this Sanggunian the naming of a newly identified road covering Purok Mangga II, Purok Ceris and leading to Barangay Tagjaguimmit as Santiago Algabre Street.

The Sangguniang Barangay deemed it appropriate to name the street in honor of the late Santiago Algabre for his remarkable deeds during his stint as the second Barangay Captain in the political history of Barangay Mayana, City of Naga, Cebu.

Algabre also known as Noy Tiago was acknowledged for his honesty, humility and effective governance as the village chief Mayana. He organized community programs that helped promote the welfare of the people in the community. He rendered his services even if he was not getting any monthly honorarium being the barangay's highest official.

One of his major contributions in the year 1978-1980 was the opening of a road that brovided access to the mountain barangays stretching from Barangay Mayana to Barangay Tagjaguimit.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

ORDINANCE NO. 2019-02 SANTIAGO ALGABRE ST. MAYANA

Page 1

SECTION 1. TITLE. This Ordinance shall be known as the official naming of SANTIAGO ALGABRE STREET in Barangay Mayana, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Santiago Algabre Street will be used as the official street name in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of Santiago Algabre Street.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signages for proper guidance and direction of motorists, pedestrians and the riding public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provision of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval in accordance with law.
