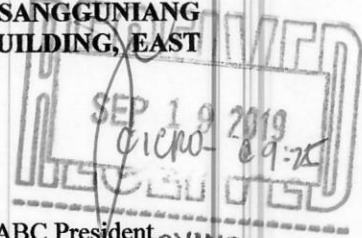

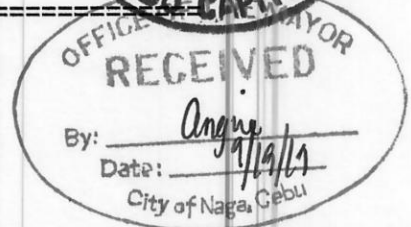

OFFICIALLY NAMING THE STREETS, BARANGAY ROADS, AND ROAD ARTERIES IN THE AREA OF JURISDICTION OF BARANGAY COGON, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM PUROK KAPIHAN TO COGON ELEMENTARY SCHOOL AS CANDIDO TALANDRON STREET; 2. FROM PUROK COGON PROPER TO CALOPES AS EUTIQUIO CABUYAO STREET; 3. FROM PUROK KABANGKALAN TO PUROK COMON AS ANTOLIN LEBRIA STREET; 4. FROM PUROK KAPIHAN TO CRUSHER AS TEODULO ABARQUEZ STREET AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Cogon passed Resolution No. 22, series of 2019 and dated April 12, 2019 strongly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the proposed names of identified streets, barangay roads and road arteries as mentioned in the above title of this proposed ordinance.

The Sangguniang Barangay deemed it proper to name the streets in honor of the kindhearted individuals whose families donated private lots for public use, and local leaders who had served the barangay with dedication, professionalism and utmost sincerity during their incumbencies.

- **CANDIDO TALANDRON** was known for his generosity. He donated a property for public use in an area where the public school and existing barangay road are located in Barangay Cogon, City of Naga, Cebu;
- **EUTIQUIO CABUYAO** was a "Tenyente del Barrio," who gained respect and admiration by his constituents because of his kindness and significant contributions during his stint as a public servant.
- **ANTOLIN LEBRIA** gained respect in the community for his benevolence for donating a part of his estate for public use and for the good deeds he shared in the community.
- **TEODULO ABARQUEZ** was known for his goodwill for donating portion of his land for public use and his compassion for helping other people.

Thus, the Sangguniang Panlungsod deemed it appropriate to recognize and give honor to the above-named individuals who, during their stints as public servant, have significantly contributed to the socio-economic development and political landscape of the City of Naga, Cebu.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) CANDIDO TALANDRON STREET;
 - b) EUTIQUIO CABUYAO STREET;
 - c) ANTOLIN LEBRIA STREET; AND
 - d) TEODULO ABARQUEZ STREET
- in Barangay Cogon, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Candido Talandron Street, Eutiquio Cabuyao Street, Antolin Lebria Street and Teodulo Abarquez Street in Barangay Cogon will be used as the official street names in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above-mentioned Street.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signages for proper guidance and direction of pedestrians and the riding public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.


SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval in accordance with law.
