ORDINANCE NO. 2019-04

Hon. Scott Juvenal A. Chiong - Sponsor SP Committee Chairman on Barangay Affairs

OFFICIALLY NAMING ALL STREETS, BARANGAY ROADS, AND ROAD ARTERIES IN THE AREA OF JURISDICTION OF BARANGAY TINA-AN, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM NATIONAL HIGHWAY TOWARDS PUROK 1 LOWER SOUTH AS LUIS BALILI STREET; 2. FROM NATIONAL HIGHWAY TOWARDS RELOCATION SITE AS RELOCATION STREET; 3. FROM NATIONAL HIGHWAY TOWARDS AIDTECH AS AIDTECH STREET, AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF

EXPLANATORY NOTE

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Tina-an passed Resolution No. 011-24-18, series of 2018 dated November 21, 2018 strongly endorsing to the Sangguniang Panlungsod of the City of Naga, Cebu the naming of identified streets, barangay roads and road arteries as mentioned in the above title of this proposed ordinance.

Luis Balili was the owner of a well-known resort in the barangay and responsible for the expansion of the existing right of way leading towards his property.

Barangay Council members and residents unanimously agreed in a public hearing to name the two (2) other streets to the names enumerated herein as follows:

Aidtech - an existing organization founded by Gloria Pocot which was then financed by many foreigners to aid for the promotion of technology that is helpful in agriculture development and local residents; and

Relocation - an existing relocation site for the inhabitants that were transferred from the seaside area following the expansion of the Apo Cement Corporation.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

ORDINANCE NO. 2019-04 STREET NAMING TINAAN

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) LUIS BALILI STREET;
- b) AIDTECH STREET; AND
- c) RELOCATION STREET;

in Barangay Tina-an, City of Naga, Cebu.

SECTION 2. OFFICIAL NAME. Luis Balili Street, Aidtech Street and Relocation Street in Barangay Tina-an will be used as the official street names in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this Ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the above-mentioned Street.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signages for proper guidance and direction of pedestrians, motorists and the riding public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed accordingly.

SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all offices concerned for their information, reference, guidance, and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval in accordance with law.
