

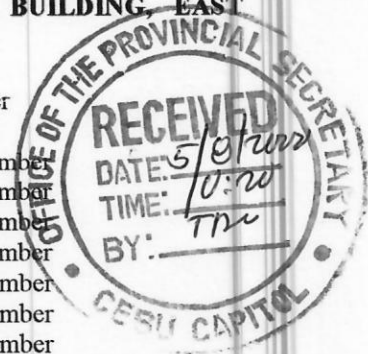

RECTIFYING THE REDUNDANT ITEM NUMBERS OF TWO (2) PLANTILLA POSITIONS AS STATED UNDER ORDINANCE NO. 2019-05, TITLED, "CREATING TWENTY-ONE (21) NEW CAREER POSITIONS IN THE CITY GOVERNMENT OF NAGA, CEBU EFFECTIVE JANUARY 01, 2020

EXPLANATORY NOTE

On October 29, 2019, this Sanggunian enacted Ordinance No. 2019-05 with the abovementioned title, which formally created 21 new positions for inclusion in the plantilla of personnel in seven (7) offices at City Hall.

The objective of this measure is to cope with the increasing demand of a functional and responsive government institution and efficiently address the basic needs of the whole citizenry in this Local Government Unit.

These new positions include, among others, medical specialist, nurses, medical technologist, sanitary inspector, midwife, administrative aides, assistant department head, supply officer, social welfare officer, environmental management specialist, administrative officer, **computer programmer, traffic operations officer**, labor and employment officer and community affairs assistant.

The City Human Resource Division, however, cited the need to rectify the listed item numbers, specifically **1011-39** and **1011-40** with corresponding position titles as **Computer Programmer 1** and **Traffic Operations Officer IV**, respectively.

Upon a careful evaluation and review on the matter, it turned out that the abovementioned item numbers already belonged to Security Agent I positions pursuant to Ordinance No. 2018-023.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This ordinance shall be known as: **RECTIFYING THE REDUNDANT ITEM NUMBERS OF TWO (2) PLANTILLA POSITIONS AS STATED UNDER ORDINANCE NO. 2019-05, TITLED, "CREATING TWENTY-ONE (21) NEW CAREER POSITIONS IN THE CITY GOVERNMENT OF NAGA, CEBU EFFECTIVE JANUARY 01, 2020.**

SECTION 2. RECTIFICATION. This August Body, upon the recommendation of the concerned committee, hereby officially changes the redundant item numbers - from 1011-39 & 1011-40 to 1011-43 & 1011-44 - respectively, more particularly described below with the corresponding position titles and offices, to wit:

SECTION 3. ORGANIZATIONAL STRUCTURE. With the rectification of the abovementioned item numbers, the organizational structure of the concerned offices are hereby modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.

SECTION 5. REPEALING CLAUSE. Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.



SECTION 7. EFFECTIVITY. This ordinance shall take effect immediately upon approval.


