WHEREAS, subjected to deliberation by this Sanggunian is the proposed Supplemental Budget No. 01 for Calendar Year (CY) 2020 containing appropriation amounting to One Hundred Million Fifty Thousand Seven Hundred Ninety Pesos (P100,050,790.00);

WHEREAS, the Statement of Funding Sources certified as correct by the Offices of the City Treasurer and City Accountant showed that the above-stated amount is available to cover the Statement of Supplemental Appropriation under the General Fund – Proper and Market Operations generated from sources specified below:

SECTION 1. APPROVAL - Supplemental Budget No. 01 for CY 2020 of the City of Naga, Cebu, containing appropriation in the amount of One Hundred Million Fifty Thousand Seven Hundred Ninety Pesos (P100,050,790.00) is hereby APPROVED.

SECTION 4. SEPARABILITY CLAUSE - If for any reason, any section or provision of this Appropriation Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. EFFECTIVITY - This Appropriation Ordinance shall take effect immediately upon its approval.
