WAIVING THE RENTAL FEES OF TENANTS LEASING CITY-OWNED COMMERCIAL SPACES AND FACILITIES FOR THE MONTH OF AUGUST 2020

EXPLANATORY NOTE

The City Government of Naga, Cebu has seen the necessity to grant a one-month waiver of payment for the month of August to tenants leasing city-owned rental spaces, whose businesses have been adversely affected by the Coronavirus Disease 2019 (COVID-19) pandemic.

The one-month reprieve is the city's way of extending the much-needed assistance to these tenants to cushion the impact of the current health crisis, which has been aggravated by the enforcement of stringent government community quarantine measures.

Thus, this Sanggunian deems it necessary to enact this ordinance granting a one-month reprieve of rental payment for the month of August 2020 to tenants leasing city-owned commercial spaces.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as **"WAIVING THE RENTAL FEES OF TENANTS LEASING CITY-OWNED COMMERCIAL SPACES AND FACILITIES FOR THE MONTH OF AUGUST 2020."**

SECTION 2. SCOPE AND COVERAGE. This ordinance shall apply to city-owned spaces specifically enumerated herein as follows:

Handwritten signatures and initials on the left margin.

Handwritten mark on the right margin.

Handwritten signatures and initials at the bottom of the page.

SECTION 3. ONE-MONTH WAIVER OF RENT. In view of the COVID-19 crisis, the rental fee of city-owned commercial spaces, as specified above, shall be deemed waived for the month of August 2020.

SECTION 4. APPROVAL. The waiver of rental fee covering the month of August 2020 is hereby **APPROVED**.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 7. COPIES FURNISHED CLAUSE. Let copies of this Ordinance be furnished to all government offices and parties concerned for their information, reference, guidance and documentation.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
