AMENDING SECTION 1 OF APPROPRIATION ORDINANCE NO. 2020-38, APPROVING SUPPLEMENTAL BUDGET NO. 7 FOR CALENDAR YEAR (CY) 2020 BY RETITLING THE PROJECT NAMES TO HARMONIZE WITH THE TITLE OF THE FUNDING SOURCE THEREOF

EXPLANATORY NOTE

On August 12, 2020, this Sanggunian enacted Appropriation Ordinance No. 2020-38, approving Supplemental Budget No. 07 for Calendar Year (CY) 2020 which contained appropriation amounting to Five Hundred Million Pesos (P500,000,000.00);

The enactment of the abovementioned Ordinance is to provide funding for three major projects of the City Government of Naga, Cebu, which consist of the following integrated information system, seaport system and road network projects.

After a series of deliberations with the concerned executive offices, the Office of the City Mayor recommended to this August Body the modification of the project names as originally mentioned in Section 1 of this Ordinance in order to harmonize and be consistent with the title reflected in the funding source of the projects, most particularly that of the enterprise-wide computerization project.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. AMENDMENT TO SECTION 1 OF APPROPRIATION ORDINANCE NO. 2020-38. Section 1 is hereby amended to read as follows: The amount of Five Hundred Million Pesos (P500,000,000.00) is hereby appropriated for Supplemental Budget No. 07 for CY 2020 of the City Government of Naga, Cebu to fund three major projects specified hereunder with the corresponding amended project names as finalized, viz:

SECTION 3. APPROVAL - Supplemental Budget No. 07 for CY 2020 of the City of Naga, Cebu, containing appropriation amounting to Five Hundred Million Pesos (P500,000,000.00) is hereby **APPROVED**.

SECTION 4. SEPARABILITY CLAUSE - If for any reason, any section or provision of this Appropriation Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. EFFECTIVITY - This Appropriation Ordinance shall take effect immediately upon approval.
