ORDINANCE NO. 2022-01

ESTABLISHING RULES AND GUIDELINES ON THE OPERATIONS OF NAGA BOWLING CENTER OF THE CITY OF NAGA, CEBU, AND SETTING THE FEES AND CHARGES THEREOF

EXPLANATORY NOTE

The widespread closure of stores and businesses in the country due to the lingering COVID-19 pandemic is unprecedented. Many of these businesses range from popular food chains, convenience stores to public market stalls and even factories.

Lessees of government-owned facilities are no exception to the devastating impact of the health crisis, which include, among others, the ten (10)-pin bowling center located on the second floor of the city-owned commercial building in Barangay East Poblacion.

Diverse Sports and Entertainment Corp. (DSEC), a startup company engaging in the business of sports and recreational entertainment, formerly operated and maintained the bowling center through a contract of lease with the City Government in the later part of 2019.

In his August 15, 2022 letter to City Hall, however, Mr. Rayrick Relampagos of DSEC, called for the pre-termination of the lease contract, citing the company's substantial losses for the maintenance of the facility's equipment and monthly operational and technical expenses since March 2020, and turning over the facility back to the custody of the City Government

The pre-termination, he said, would give the company an opportunity to resort to other business endeavors and recoup its losses.

With the pre-termination of the lease contract, the City Government has left with no other option except to take over the management, operation and maintenance of the bowling center, thus giving birth to this proposed measure that establishes the rules and guidelines of the sports facility, and imposes fees and charges thereof.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. – This Ordinance shall be known as **“ESTABLISHING RULES AND GUIDELINES ON THE OPERATIONS OF NAGA BOWLING CENTER OF THE CITY OF NAGA, CEBU, AND SETTING THE FEES AND CHARGES THEREOF.”**

SECTION 2. SCOPE AND APPLICATION. – This Ordinance shall govern the bowling center operation, fees and charges, house rules, guidelines and other imposition thereof.

SECTION 3. DEFINITION. - For the purpose of this Ordinance, the following terms are hereby defined.

- a) Alley - Surface of the lanes which is made of maple, pine or urethane boards.
- b) Approach - Portion of the lane (path) from the back of the ball return area to the foul line.
- c) Bowling - is a game in which you roll a heavy ball down a narrow track towards a group of wooden objects and try to knock down as many of them as possible.
- d) Bowler - is someone who plays bowls or goes bowling.
- e) Bystanders - a person who stays at the bowling facility for more than 30 minutes without _____.
- f) Lane - the playing surface.
- g) Mid lane - bowling in the middle third area of the lane.
- h) Pin Deck - where pins are located.
- i) Pit - the portion of the lane behind the pin deck.

SECTION 4. HOURS OF OPERATION. - No person shall keep open, operate or play upon the bowling alley, ball or pin alley, beyond the operating hours from **11 a.m. to 11 p.m.**

SECTION 5. IMPOSITION OF FEES AND CHARGES. - There are hereby levied fees and charges to be collected. Twenty percent (20%) discount on the imposed fees and charges will be granted to Senior Citizens, Solo Parents, PWDs, students and to bonafide City of Naga residents.

SECTION 6. ADMINISTRATIVE PROVISION/HOUSE RULES. -

- a) To ensure safety, assigned tables, lanes, and balls shall be thoroughly sanitized prior to use;
- b) Proper bowling attire must be observed. For hygienic purposes, players are required to wear socks before putting on bowling shoes. Management reserves the right to refuse anyone not wearing proper bowling attire;
- c) Bowlers are required to wear face masks;
- d) Sanitize frequently – alcohol dispenser are provided within the bowling area;
- e) Maximum of four (4) bowlers are allowed per lane. Physical distancing is to be observed at all times;
- f) Players waiting for their turn should remain seated;
- g) Stepping and/or going beyond the bowler's approach is strictly prohibited;
- h) One-way flow of traffic in the settee and will be asked to stay in the common area;
- i) Non-players are not allowed for one hour stay;
- j) Drunk bowlers are not allowed to play;
- k) Valid ID will be presented upon claiming the 10% discount (senior citizens, PWDs, solo parents and certified Nagahanons);
- l) Don't loft the ball. Keep the ball as close to the floor as possible before releasing it;
- m) Food and beverages are not allowed in the playing lane area;
- n) Stepping over the foul line is strictly prohibited;
- o) Time of operation is from 11:00 a.m. to 11:00 p.m.;

- m) Valid ID will be presented upon claiming the twenty percent (20%) discount (senior citizens, solo parents, certified Nagahanons);
- n) Do not loft the ball. Keep the ball as close to the floor as possible before releasing it;
- o) Food and beverages are not allowed in the playing lane area;
- p) Stepping over the foul line is strictly prohibited;
- q) Time of operation is from 11:00 a.m. to 11:00 p.m.; and
- r) Student during class hours are not allowed unless clearance from the teacher is secured

SECTION 7. PENALTIES. – Any person who violates any of the provisions shall be forced out of the facility.

SECTION 8. IMPLEMENTING OFFICE. – The City Treasurer’s Office shall be the leading office to ensure the proper implementation of this Ordinance in coordination with the Office of the City Mayor and other concerned offices.

SECTION 9. SEPARABILITY CLAUSE. – If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected thereby shall remain valid and subsisting.


SECTION 10. REPEALING CLAUSE. – All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 11. EFFECTIVITY. – This Ordinance shall take effect immediately upon approval.


