**ORDINANCE NO. 2023-11**

**RECTIFYING THE NUMBERING OF ARTICLES 17 TO 25 OF CHAPTER III (PERMIT AND REGULATORY FEES) OF CITY ORDINANCE NO. 2022-04, TITLED: THE "2022 REVISED REVENUE CODE OF THE CITY OF NAGA, CEBU"**

**EXPLANATORY NOTE**

On November 11, 2022, the 5<sup>th</sup> Sangguniang Panlungsod enacted City Ordinance No. 2022-04, or the "2022 REVISED REVENUE CODE OF THE CITY OF NAGA," CEBU pursuant to Sections 129 and 191 of R.A. 7160, otherwise known as the Local Government Code of 1991, which empowers local government units to create sources of revenue and adjust tax rates consistent with the basic policy of local autonomy.

The Sanggunian Secretariat is set to engage the services of a bookbinding company for distribution of the newly approved Revenue Code to the City of Naga-based firms and business establishments when, upon review, it noticed a typographical error under Chapter III (Permit and Regulatory Fees) wherein both the "*Permit Fee for Disposal and Wastes*" and "*Permit Fee for Extraction of Underground Water/Surface Water/Seawater*" carry the same Article number "17."

To correct this matter, Article 17, titled: *Permit Fee for Extraction of Underground Water/Surface Water/Seawater* on page 54 of the Code should have been numbered Article 18, and the rest of the number sequence beginning this article will just follow in the proper order.

This August Body hereby emphasizes that there has been no changes in the substance of the Code, but deems it necessary to put the numbering of the above-mentioned articles in the proper context through this corrective ordinance.

**BE IT ORDAINED**, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

**SECTION 1. PURPOSE.** There is a need to correct the numbering of Articles under Chapter III (Permit and Regulatory Fees) of Ordinance No. 2022-04 as both the "*Permit Fee for Disposal and Wastes*" and "*Permit Fee for Extraction of Underground Water/Surface Water/Seawater*" carry the same Article number "17."

**SECTION 2. RECTIFICATION.** the August Body hereby officially rectifies the aforementioned typographical error, and consequently, the title: "*Permit Fee for Disposal and Wastes*" shall retain the Article number 17, while "*Permit Fee for Extraction of Underground Water/Surface Water/Seawater*" shall be numbered Article 18. The rest of the number sequence beginning Article 18 of Chapter III shall now read as follows:

"Article 21. Permit Fee on Circus and Other Parades

"Article 22. Permit Fee For The Conduct of Group Activities

"Article 23. Permit Fee on Film-Making

"Article 24. Permit Fee on Bicycles


"Article 25. Special Permits And Charges"
