AMENDING THE POSITION TITLE OF PLANTILLA POSITION CREATED UNDER ORDINANCE NO. 2022-A-01 FROM ADMINISTRATIVE OFFICER V (HRMO IV) TO ADMINISTRATIVE V (HRMO III) IN THE OFFICE OF THE CITY ADMINISTRATOR **HUMAN RESOURCE DIVISION**

EXPLANATORY NOTE

On October 12, 2022, the 5th Sangguniang Panlungsod enacted Ordinance No. 2022-A-01, titled: "CREATING NEW CAREER AND NON-CAREER POSITONS UNDER THE DIFFERENT OFFICES OF THE CITY GOVERNMENT OF NAGA, CEBU EFFECTIVE JANUARY 01, 2023, AND PROVIDING FUNDS THEREOF."

Subjected to deliberation is the request of Ms. Darean M. Heyrosa, Human Resource Division (HRD) Head-Designate, for approval of the correction of the title of the abovementioned plantilla position in the Office of the City Administrator HRD.

This Sanggunian deems it justifiable and appropriate to make the necessary corrections through the enactment of this measure.

NOW THEREFORE, be it ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu that:

SECTION 1. TITLE. This Ordinance shall be known as "AMENDING THE POSITION TITLE OF PLANTILLA POSITION CREATED UNDER ORDINANCE NO. 2022-A-01 FROM ADMINISTRATIVE OFFICER V (HRMO IV) TO ADMINISTRATIVE V (HRMO III) IN THE OFFICE OF THE CITY ADMINISTRATOR HUMAN RESOURCE DIVISION."

SECTION 2. AMENDMENT. Section 4 of Ordinance No. 2022-A-01 is hereby amended to read as follow:

SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
