AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG, IN THE CASE OF THE EXECUTIVE DEPARTMENT, AND THE HONORABLE CITY VICE MAYOR VIRGILIO M. CHIONG, IN THE CASE OF THE LEGISLATIVE DEPARTMENT, BOTH OF THIS LOCAL GOVERNMENT UNIT (LGU), TO CAUSE THE AUGMENTATION OF FUNDS FROM ONE ITEM TO ANOTHER WITHIN THE SAME EXPENDITURE CLASS OF APPROPRIATIONS, WHEN NEED ARISES, IN THE FISCAL YEAR (FY) 2024 APPROVED ANNUAL BUDGET, OF **EVERY DEPARTMENT IN THIS LGU FOR THE REMAINING PERIOD OF FY 2024**

BE IT ORDAINED, as it is hereby ORDAINED by the 5th Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. Augmentation of funds, pursuant to Section 336 of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, from one item to another within the same expenditure class of the same office, is hereby AUTHORIZED.

SECTION 2. That the augmentation shall be allowed for appropriations that need to be augmented in order to maximize and fast track the delivery of basic services for the remaining months of 2024.

SECTION 3. That the amount to be augmented shall be made only after Office Order has been issued by the Local Chief Executive, in the case of the executive department, and the City Vice Mayor, in the case of the legislative department, both of this LGU.

SECTION 4. Prior to the issuance of Office Orders, all requesting departments/offices shall be required to refer the augmentation request to the Office of the City Budget Officer to ascertain the availability of funds subject for augmentation.

SECTION 5. That the augmentation is within the bounds of law pursuant to Section 336 of R.A. 7160.

SECTION 6. This Ordinance shall take effect immediately until December 31, 2024.
