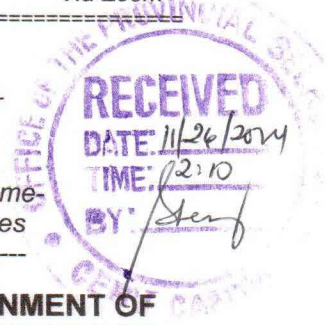

CREATING TEN (10) NEW PLANTILLA POSITIONS IN THE CITY GOVERNMENT OF NAGA, CEBU UNDER THE OFFICES OF THE CITY MAYOR, CITY ADMINISTRATOR AND CITY HEALTH EFFECTIVE JANUARY 2025

EXPLANATORY NOTE

Section 76 of Republic Act (RA) 7160, otherwise known as the Local Government Code of 1991 states that "Every local government unit (LGU) shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission."

The City Government of Naga, Cebu considers it necessary to create new plantilla positions in order to maintain a strong and dynamic LGU that is responsive to the needs of its growing population through efficient and effective delivery of basic services to its constituents.

These new plantilla positions will sufficiently provide new opportunities to the city's workforce and inspire them to perform their assigned tasks with diligence, honesty and good faith for the benefit and welfare of the Nagahanons.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as: **AN ORDINANCE CREATING TEN (10) NEW PLANTILLA POSITIONS IN THE CITY GOVERNMENT OF NAGA, CEBU UNDER THE OFFICES OF THE CITY MAYOR, CITY ADMINISTRATOR AND CITY HEALTH EFFECTIVE JANUARY 2025.**

SECTION 2. POSITIONS. These new plantilla positions with the corresponding item numbers and salary grades specified below for the above-stated offices are hereby created immediately, to wit:

SECTION 3. ORGANIZATIONAL STRUCTURE. With the creation of these new positions mentioned in Section 2 hereof, the organizational structures of the above-stated offices are hereby modified accordingly.

SECTION 4. APPROPRIATION. The City Government of Naga, Cebu shall appropriate the necessary funds in its annual budget to cover the salaries and other benefits of the employees who will be appointed to the positions abovementioned.

SECTION 5. SEPARABILITY CLAUSE. Should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.

SECTION 6. REPEALING CLAUSE. Any other ordinance or parts thereof found inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 7. COPY FURNISHED. The Civil Service Commission, Office of the City Mayor, City Budget Office, the City Human Resources Management Office and other concerned government offices/agencies shall be furnished copies of this Ordinance for recording purposes, guidance and appropriate action.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval and after due compliance with all the pertinent requirements as mandated by R.A. 7160.


