
RESOLUTION NO. 033-F-2006

WHEREAS, with the establishment of the Municipal Plant Nursery under the care and supervision of the Office of the Municipal Agriculturist, there is a need to pass an Ordinance imposing price on seedlings which are offered for sale in the said Nursery, so as to generate income to offset its operation and maintenance expenses.

NOW THEREFORE, Be it resolved by the Sangguniang Bayan of Naga, Cebu, on motion of Hon. Rodrigo A. Navarro, seconded by Hon. Porferio V. Resaba, Jr. to promulgate the following Ordinance:

ORDINANCE NO. 003-2006

AN ORDINANCE FIXING PRICES ON PLANTS AND SEEDLINGS OFFERED FOR SALE AT THE MUNICIPAL PLANT NURSERY OF NAGA, CEBU

BE IT ENACTED by the Sangguniang Bayan of Naga, Cebu that:

Section 1. Definitions. When used in this Article:

- a. Nursery means a place where trees, shrubs and plants are raised for sale or transplanting.
- b. Nurseryman means a person who manages a nursery for the cultivation and raising of tress, shrubs and plants.

Section 2. Imposition and Manner of Payment. The following prices per seedling, shrub and plant offered for sale in the Municipal Plant Nursery are hereby fixed as follows:

All payments shall be rendered at the Municipal Treasurer's Office upon presentation of a Payment Order Slip which shall be issued by the Municipal Agriculture Officer or the assigned Nurseryman, bearing the quantity and kind of tree/shrub/plant.

Section 3. Administrative Provision. The Municipal Agriculture Officer or the Nurseryman shall determine the trees/plants available for sale and issue the Payment Order Slip. The Municipal Agriculture Officer shall keep a record of all sale transaction which shall contain the date, Official Receipt Number, Name of the Purchaser, quantity and name of plants/trees purchased, for documentation purposes.

Section 4. Effectivity. This Ordinance shall take effect immediately upon approval.
