RESOLUTION NO. 015-A-2005

WHEREAS, the Municipal Government of Naga, Cebu has just completed the construction of the Naga Lawn Tennis Court and is currently undertaking the construction of the Naga Basketball Court, both located at the reclaimed area, East Poblacion, Naga, Cebu, which is open to the general public anytime of the day or night;

WHEREAS, the said Tennis and Basketball Court are installed with adequate lighting facilities for the convenience of players during night time;

WHEREAS, it is the sentiment of this August Body that fees be charged to players during night time, particularly from 6:00 P.M. to 6:00 A.M., in order to offset the cost of power consumption and to maintain its sanitary condition and serviceability;

NOW THEREFORE, Be it resolved by the Sangguniang Bayan of Naga, Cebu, on motion of Hon. Pablo A. Abangan, to enact the following Ordinance:

ORDINANCE NO. 2005-001

AN ORDINANCE IMPOSING FEES, RULES AND REGULATIONS FOR THE USE OF THE NAGA LAWN TENNIS COURT AND THE BASKETBALL COURT LOCATED AT THE RECLAIMED AREA, EAST POBLACION, NAGA, CEBU

BE IT ENACTED by the Sangguniang Bayan of Naga, Cebu that:

SECTION 1. IMPOSITION OF FEES: For use of the Naga Lawn Tennis Court and the Naga Basketball Court during night time, particularly from 6:00 P.M. to 6:00 A.M., players are required to pay a usage fee of P50.00/hour/court. The fees imposed herein shall be paid to the Municipal Treasurer or his duly authorized representative who shall issue the corresponding Official Receipt upon payment right after the game. For purposes of computation, a fraction of an hour is equivalent to one hour.

SECTION 2. RULES AND REGULATIONS:

- a. The use of the Naga Tennis and Basketball Court shall be accommodated on a first come-first serve basis. Court players shall register with the authorized personnel assigned by the Municipal Mayor for proper scheduling and for record purposes.
- b. Cleanliness shall be strictly observed by the players and viewers.
- c. Gambling and betting, in any form shall not be allowed inside the Courts.
- d. Drinking of hard liquor and/or beer shall not be allowed inside the Courts.

SECTION 3. PENALTY.

- a. For refusal to pay the usage fees, players shall be denied use of the Courts until the fees due can be paid to the Municipal Treasurer or his duly authorized representative.
- b. Violators of letters b, c, d of Section 2 above shall be dealt with in accordance with pertinent, existing Local/National Ordinances.

SECTION 4. SEPARABILITY CLAUSE - Should any provision of this Ordinance be declared by any court of competent jurisdiction to be void or unconstitutional, the portions hereof which are not so declared shall remain in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately.
