AN ORDINANCE NAMING THE NEW BUILDING LOCATED AT THE RECLAMATION AREA AT THE BACK OF THE NEW CITY HALL AS ENAN CHIONG ACTIVITY CENTER

WHEREAS, the City Government of Naga, Cebu is almost through with the construction of a new building located at the reclamation area at the back of the new City Hall to replace the Naga Sports Complex;

WHEREAS, it is the consensus of this Body to name the new building in honor of the late former Mayor Ferdinand Mendiola Chiong, commonly and publicly known to Naganians as Enan Chiong, in recognition of his exemplary performance in public service and his outstanding contribution to the development of the City of Naga, Cebu;

NOW THEREFORE, on motion of Hon. Porferio V. Resaba, Jr., seconded by all Sangguniang Panlungsod Members present, to enact, promulgate this Ordinance above titled:-

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu that:

SECTION 1. The new building constructed by the City Government of Naga, Cebu, located at the reclamation area, at the back of the new City Hall, is hereby named as **ENAN CHIONG ACTIVITY CENTER**;


SECTION 3. This Ordinance shall take effect immediately.




