ORDINANCE NO. 2013-002

AN ORDINANCE RATIFYING THE FEES PRESCRIBED IN THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT (RA) No. 10172 OTHERWISE KNOWN AS AN ACT FURTHER AUTHORIZING THE CITY OR MUNICIPALITY CIVIL REGISTRAR OR CONSUL GENERAL TO CORRECT CLERICAL OR TYPOGRAPHICAL ERRORS IN THE DAY AND MONTH IN THE DATE OF BIRTH OR SEX OF A PERSON APPEARING IN THE CIVIL REGISTER WITHOUT NEED OF A JUDICIAL ORDER

Whereas, Section 8 of RA No. 10172 provides that the City or Municipal Civil Registrar or the Consul General shall be authorized to collect reasonable fees as a condition for accepting the petition for correction of erroneous entry concerning the day and month in the date of birth or sex of a person;

Whereas, Rule 10 of the implementing rules and regulations of RA No. 10172 requires that the local legislative body shall ratify the fees prescribed by the Act upon effectivity of Administrative Order No. 1 series of 2012, which pertains to the rules and regulations governing the implementation of RA No. 10172;

Now, therefore, be it ordained by the Sangguniang Panlungsod of the City of Naga, Cebu that:

SECTION I. This Ordinance shall be known as the "Ratification of the Fees Prescribed In the Implementing Rules and Regulations of RA 10172 Ordinance of the City of Naga Cebu"

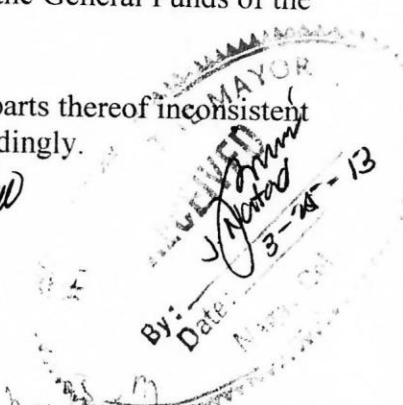
SECTION II. The amount of THREE THOUSAND (P3,000.00) PESOS shall be collected from every petitioner for petition to correct clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the Civil Register, in accordance with R.A. 10172. This payment shall be paid to the City Treasurer or his/her duly authorized representative, who shall issue the corresponding Official Receipt for such payment. Provided, an indigent petitioner shall be exempt from paying the required payment, upon the presentation of a Certification from the City's Social Welfare Office that the petitioner/document owner is considered indigent.

SECTION III. All fees collected shall accrue and be integrated to the General Funds of the City of Naga, Cebu.

SECTION IV. REPEALING CLAUSE. All past Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION V. EFFECTIVITY CLAUSE. This Ordinance shall take effect fifteen days after its publication in a newspaper of general circulation within the City or posting in conspicuous places in the City.




