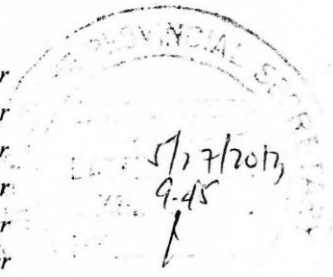

**ORDINANCE NO. 2013-006**

AN ORDINANCE ESTABLISHING THE IMPLEMENTING GUIDELINES OF THE CREATION OF THE CITY OF NAGA ECOLOGY CENTER

WHEREAS, Section 10 of Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, provides that Local Government Units (LGUs) shall be primarily responsible for the implementation and enforcement of the provisions of RA 9003 within their respective jurisdictions;

WHEREAS, the City Government of Naga, Cebu has established the City of Naga Ecology Center in pursuance to such provision and to facilitate the efficient and sustainable solid waste management and serve as a model to other LGUs;

WHEREAS, the City Government of Naga, Cebu has entered into a twenty-five year service agreement with FDRCon Company, Inc., in line with the establishment of the City of Naga Ecology Center;

WHEREAS, the City of Naga Ecology Center may accept and process solid waste coming from other cities, municipalities and private entities, upon the approval of the City Mayor and the City Council, to broaden the scope of preservation and protection of the environment and to maximize the use of the Ecology Center;

WHEREAS, the City Government of Naga, has recognized the need to formulate the implementing guidelines for the City of Naga Ecology Center;

Now, therefore, be it ordained by the Sangguniang Panlungsod of the City of Naga that:

CHAPTER I  
General Provisions

**SECTION 1. TITLE.** This Ordinance shall be known as the "The Implementing Guidelines of the City of Naga Ecology Center Ordinance."

**SECTION 2. POLICY.** It is hereby declared a policy of the City that the City of Naga Ecology Center shall operate to help protect the health of the public and the environment by processing the solid wastes of the City and such wastes coming from other cities, municipalities and private entities for a fee to sustain its operation.

**SECTION 3. DEFINITION OF TERMS.** As used in this Ordinance, the following terms shall mean:

Ecology Center - the place or location where the City has established a facility, through a partnership with FDRCon Company, to process solid wastes.

Solid wastes - refer to all discarded household, commercial wastes, non-hazardous institutional and industrial waste, street sweepings, construction debris, agricultural waste, and other non-hazardous/non-toxic solid waste.

Tipping fee - the fee paid for the processing of the solid waste in the Ecology Center

## CHAPTER II IMPLEMENTING GUIDELINES

### **SECTION 4. CENTRALIZED SOLID WASTE PROCESSING IN THE CITY OF NAGA.**

4.1 To properly monitor the solid waste generated within the City of Naga and ensure that its processing is in accordance to Republic Act 9003, all solid waste processing and related activities shall be centralized and only done inside the City of Naga Ecology Center.

4.2 Similarly, all types of solid wastes which are covered under RA 9003 and which are collected from outside the City of Naga shall only be accepted and processed inside the City of Naga Ecology Center.

### **SECTION 5. INCOME OF THE CITY OF NAGA FROM THE CITY ECOLOGY CENTER.**

5.1 The City of Naga, Cebu with the presence and operation of its City Ecology Center has the capability to promote the compliance of the provisions set by RA 9003 to other local government units and private entities outside the City of Naga, Cebu. Hence, the City of Naga may extend the solid waste processing services of the City Ecology Center, provided that there must be prior approval of the City Mayor duly authorized by the Sangguniang Panlungsod.

5.2 Other LGUs, except the Municipality of Minglanilla, and private entities outside of the City of Naga shall pay a tipping fee of P400 per ton of solid waste.

5.3 The City of Naga shall then receive a tipping fee percentage share of 10-percent from the total realized gross income of FDRCon Co. Inc.

## CHAPTER III FINAL PROVISION

**SECTION 6. REPEALING CLAUSE.** All circulars, memoranda, rules and regulations or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.



**SECTION 7. SEPARABILITY CLAUSE.** If, for any reason or reasons, any part or provisions of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereby which are not affected thereby shall continue to be in full force and effect.

**SECTION 7. EFFECTIVITY CLAUSE.** This Ordinance shall take effect fifteen days after its publication in a newspaper of general circulation within the City and posting in conspicuous places in the City.


