ORDINANCE NO. 2015-002

WHEREAS, by virtue of Presidential Proclamation No. 682, issued by then President Corazon C. Aquino on 28 January 1991, February of every year has been declared as Civil Registration Month;

WHEREAS, local government units, through the Local Civil Registry Offices are enjoined to participate in the celebration by conducting relevant activities which would raise the consciousness of the populace on the importance of civil registry;

WHEREAS, in observance of the declaration of the Civil Registration Month, it is the policy of this Local Government Unit to remind the whole citizenry of the City of Naga, Cebu on their duty to register acts and events concerning status of persons, appreciate the legal, administrative and statistical values of civil registry documents;

NOW THEREFORE, Be it resolved by the Sangguniang Panlungsod of the City of Naga, Cebu, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Othello M. Chiong, to enact as it hereby enact the following :

AN ORDINANCE DECLARING FEBRUARY 9 TO 13, 2015 AND EVERY WEEK (CLOSEST TO FEBRUARY 14) OF EVERY YEAR AS "CIVIL REGISTRATION CONSCIOUSNESS WEEK" IN THE CITY OF NAGA, CEBU

Be it ordained by the Sangguniang Panlungsod of the City of Naga, Cebu that:

Section 1. TITLE. - This Ordinance shall be known as the "CIVIL REGISTRATION CONSCIOUSNESS WEEK IN THE CITY OF NAGA, CEBU".

Section 2. POLICY. - It is the policy of the City Government of Naga, Cebu to observe the declaration of every February as Civil Registration Month, pursuant to Presidential Proclamation No. 682, in order to raise the consciousness and awareness of the whole citizenry of the City of Naga, Cebu on their duty to register acts and events concerning status of persons, appreciate the legal, administrative and statistical values of civil registry documents;

Section 3. DECLARATION. It is hereby declared that FEBRUARY 9 TO 13, 2015 AND EVERY WEEK (CLOSEST TO FEBRUARY 14) OF EVERY YEAR, AS "CIVIL REGISTRATION CONSCIOUSNESS WEEK IN THE CITY OF NAGA, CEBU" ;

Section 4. CONDUCT OF PROGRAMS, PROJECTS AND ACTIVITIES. In observance of such declaration, the Office of the Local Civil Registrar of the City of Naga, Cebu shall:

1. Cause the issuance of local civil registry documents FREE OF CHARGE; and
2. Initiate, implement and conduct programs, projects and activities relevant to this declaration, chargeable against available local funds, subject to the approval of the Local Chief Executive.

Section 5. SEPARABILITY CLAUSE. If, for any reason, any provision of this Ordinance shall be declared invalid or unconstitutional, the remaining provisions not affected, shall be valid and enforceable.

Section 6. EFFECTIVITY. This Ordinance shall take effect immediately.


