ORDINANCE NO. 2016-001

AN ORDINANCE AMENDING ITEM 12 UNDER "CERTIFICATION, MISCELLANEOUS AND OTHER SERVICES" OF SECTION 4B.01, ARTICLE B, CHAPTER IV OF CITY ORDINANCE NO. 2012-001 OR THE REVENUE CODE 2012 OF THE CITY OF NAGA, CEBU, IN A MANNER THAT THE SERVICE FEE FOR BREQS (BATCH REQUEST ENTRY SYSTEM) NSO PROCESSING AND ISSUANCE, SHALL BE LOWERED DOWN FROM P75.00 TO P20.00 PER ISSUANCE

WHEREAS, Item 12 under "CERTIFICATION, MISCELLANEOUS AND OTHER SERVICES" of Section 4B.01, Article B, Chapter IV of City Ordinance No. 2012-001 or the Revenue Code 2012 establishes the imposition of service fee of SEVENTY FIVE (P75.00) PESOS for the processing and issuance of documents under the BREQS NSO (Batch Request Entry System – National Statistics Office);

WHEREAS, taken up and subjected to deliberation in a series of sessions conducted, was the letter request from City Mayor Valdemar M. Chiong to amend the service fee collected by the Local Civil Registrar for the processing and issuance of BREQS NSO Certifications from P75.00 to P20.00 per issuance so as to be "at par" with other service shops rendering the same service within the City;

WHEREAS, this Body deemed it appropriate to favorably act on the afore-stated request as part of the constituent service mandate of this administration;

NOW THEREFORE, Be it ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, with all members concurring herein that:

Section 1. Item 12 under "CERTIFICATION, MISCELLANEOUS AND OTHER SERVICES" of Section 4B.01, Article B – LOCAL CIVIL REGISTRY FEES, Chapter IV – SERVICE FEES of City Ordinance No. 2012-001 – THE REVENUE CODE OF 2012 is hereby amended in a manner that the imposition of service fee be lowered down from SEVENTY FIVE (P75.00) PESOS to TWENTY (P20.00) PESOS per document;

Section 2. Applicability Clause. All other matters relating to the imposition of this Ordinance shall be governed by pertinent provisions of the City Revenue Code of 2012.

Section 3. Repealing Clause. All Ordinances, rules and regulations, or part thereof, in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed, modified accordingly.


Section 4. Effectivity. This Ordinance shall take effect immediately.
