ORDINANCE NO. 2016-002

AN ORDINANCE AMENDING SECTION 20, CHAPTER IV - FOOD ESTABLISHMENTS/FOOD MANUFACTURERS/MARKETS AND SECTION 48, CHAPTER XII OF ORDINANCE NO. 2010-004 OR THE SANITATION CODE OF THE CITY OF NAGA, CEBU

WHEREAS, pertinent provisions of Ordinance No. 2010-004 or the Sanitation Code of the City of Naga, Cebu establishes the following impositions:

"Section 20 – Chapter IV – Food Establishments/Food Manufacturers/Markets.

All food establishment personnel are required to conduct proper hygiene in processing food as enumerated below:

a) Cooks shall wear clean working garments and should have hairnets, caps and apron;

b) Observe good personal hygiene;

c) Wash hands thoroughly with soap and water and dry them with a clean or disposable towel or suitable hand drying equipment immediately before working or after visiting the toilet

d) No food handler with long fingernails should be allowed to work;

e) No food handler with active skin infection should be allowed to work;

f) No manicured fingernails;

g) No jewelry except wedding band should be worn by the food handler during his/her time of duty; and

Section 48. – Chapter XII - TONSORIAL AND BEAUTY ESTABLISHMENTS. Tonsorial or beauty establishments shall be required to secure the proper Sanitary Permit from the City Health Office";

WHEREAS, taken up and subjected to deliberation in a series of sessions conducted, was the need to amend the aforementioned Sections to promote public health safety, especially food establishments and beauty parlors in accordance with pertinent provisions of P.D. 856 or the Code on Sanitation of the Philippines, as contained in a letter of request submitted by Sanitary Inspection Virneil M. Alinsonorin, RMT;

WHEREAS, this Body deemed it appropriate to favorably act on the afore-stated request/measure, in compliance with P.D. 856 or the Code on Sanitation of the Philippines and as part of the constituent service mandate of this administration;

NOW THEREFORE, Be it ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, with all members concurring herein that:

- Section 1. Section 20 Chapter IV "Food Establishments/Food Manufacturers/Markets" is hereby amended to read as follows:
 - a. All food establishments restaurants, cafeterias, carenderias, refreshment parlors, coffee shops and other similar food service establishments should install a utensil sterilizer for spoons and forks.
 - b. All food establishment personnel, including those in restaurants, cafeterias, carenderias, water refilling stations, refreshment parlors, coffees shops and all other similar food service establishments, regardless of classification, existing within the City of Naga, Cebu are required to conduct proper hygiene in processing food as enumerated below:
 - Cooks shall wear clean working garments and should have hairnets, caps, aprons and plastic transparent mask;

- Observe good personal hygiene;

- Wash hands thoroughly with soap and water and dry them with a clean or disposable towel or suitable hand drying equipment immediately before working or after visiting the toilet
- No food handler with long fingernails should be allowed to work;
- No food handler with active skin infection should be allowed to work;

- No manicured fingernails;

- No jewelry except wedding band should be worn by the food handler during his/her time of duty;
- Section 2. Section 48. Chapter XII TONSORIAL AND BEAUTY ESTABLISHMENTS is hereby amended to read as follows:

Tonsorial or beauty establishments, including barber shops, beauty parlors, hairdressing and manicuring establishments, figure slendering salons, facial and skin parlors shall be required to install ultra violet rays equipments to prevent disease transmission.

- Section 3. All other parts, sections, Chapters of the Sanitation Code of the City of Naga, Cebu shall remain in full force and effect.
- Section 4. Separability Clause. If for any reason, any Section or Provision of this Ordinance shall be held to be unconstitutional or invalid by a competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.
- Section 5. Applicability Clause. All other matters relating to the impositions of this Ordinance shall be governed by pertinent provisions of the Sanitation Code of the City of Naga, Cebu.

Section 6. Repealing Clause. All Ordinances, rules and regulations, or part thereof, in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed, modified accordingly.

Section 7. Effectivity. This Ordinance shall take effect immediately.
