**ORDINANCE NO. 2016-003**

**AN ORDINANCE CONVERTING THE OLD MUNICIPAL BUILDING LOCATED AT BARANGAY EAST POBLACION, CITY OF NAGA, CEBU AS THE CITY'S HOME OF LEGISLATURE AND OFFICIALLY NAMING THE SAME AS THE "LEGISLATIVE BUILDING"**

WHEREAS, the old Municipal Building located at Barangay East Poblacion, this City has been repaired, renovated and transformed in a manner that all the offices of the Vice Mayor, the Sangguniang Panlungsod Members, the Secretary's Office and the Session Hall shall be located on the first floor, for easy access and inter-action with each offices, in pursuit for an effective legislation;

WHEREAS, with this transformation, there is a need to establish and officially name the said building as the "Legislative Building" and transfer all the offices of legislature to the same building;

NOW THEREFORE, Be it ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, with all members concurring herein that:

Section 1. NAME. The old Municipal Building located at Barangay East Poblacion, City of Naga, Cebu, is hereby converted as the City's home of legislature and officially named as the "LEGISLATIVE BUILDING";

Section 2. TRANSFER OF LEGISLATURE. Upon approval by the City Mayor for the occupancy of the City Legislative Building, all offices and personnel under the Legislative Department, together with all equipments and facilities, shall be transferred from the City Hall to the Legislative Building;

Section 3. Repealing Clause. All Ordinances, rules and regulations, or part thereof, in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed, modified accordingly;


Section 4. Effectivity. This Ordinance shall take effect immediately.




