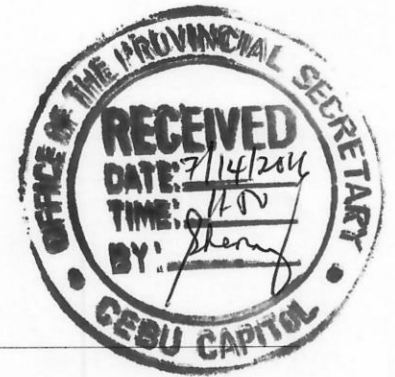

ORDINANCE NO. 2016-005

AN ORDINANCE NAMING THE EIGHT-LANE 400-METER RUBBERIZED TRACK OVAL LOCATED AT CITY OF NAGA CENTRAL ELEMENTARY SCHOOL COMPOUND AS TEODORO “DORING” MENDIOLA SR. SPORTS FIELD AND OVAL

WHEREAS, Article XIV, Section 19 (1) of the 1987 Constitution provides that “The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;”

WHEREAS, the City Government of Naga, Cebu has just completed the eight-lane 400-meter rubberized track oval project located within the compound of the City of Naga Central Elementary School, Barangay Central Poblacion of this city;

WHEREAS, it was the consensus of this Body to name the abovementioned track oval as Teodoro “Doring” Mendiola Sr. Sports Field and Oval in honor of the late Teodoro S. Mendiola Sr., who served as mayor of the then Municipality of Naga, Cebu from 1926 to 1929;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. This ordinance shall be called as an “ORDINANCE NAMING THE EIGHT-LANE 400-METER RUBBERIZED TRACK OVAL LOCATED AT CITY OF NAGA CENTRAL ELEMENTARY SCHOOL COMPOUND AS TEODORO “DORING” MENDIOLA SR. SPORTS FIELD AND OVAL.”


SECTION 2. That an entrance fee in the amount of ten pesos (P10.00) shall be imposed upon the bona fide residents of the City of Naga and twenty pesos (P20.00) for non-city residents when they use the sports facility, except student-athletes and coaches who belong to any schools within the city’s territorial jurisdiction.

SECTION 3. Copies of this Ordinance be furnished the National Historical Institute, Office of the President of the Republic of the Philippines and other concerned offices for their information, reference and documentation


SECTION 4. This Ordinance shall take effect immediately.


