AN ORDINANCE NAMING THE COVERED TENNIS COURT AT THE CITY PLAZA AS CITY OF NAGA VOLLEY AND LOB (VAL) TENNIS COURT

WHEREAS, Article XIV, Section 19 (1) of the 1987 Constitution provides that “The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;”

WHEREAS, the City Government of Naga, Cebu has already completed a covered tennis court project, one of the new sports facilities located at the City Public Plaza;

WHEREAS, it was the consensus of this Body to name the abovementioned sports facility as City of Naga Volley and Lob (VAL) Tennis Court.

NOW THEREFORE, BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:



SECTION 2. Copies of this Ordinance be furnished the National Historical Institute and other concerned offices for their information, reference and documentation.


SECTION 3. This Ordinance shall take effect immediately.
