AN ORDINANCE NAMING THE NEW HEALTH CARE BUILDING OF THE CITY OF NAGA, CEBU AS VICENTE MENDIOLA HEALTH CENTER (VMHC)

WHEREAS, Chapter 2 of Section 13 (c) (4) of RA 7160 otherwise known as the Local Government Code of 1991 empowers the Sanggunians of component cities and municipalities to rename city and municipal hospitals, health centers and other health facilities within its territorial jurisdictions;

WHEREAS, in compliance with Section 13 (f) of the same Code, the Local Health Board (LHB) unanimously passed Resolution No. 003-2016 dated August 25, 2016 recommending for the approval of Vicente Mendiola Health Center as the official name of this new health facility;

WHEREAS, it was the consensus of this Body to name the two-storey health care facility located at Barangay East Poblacion as Vicente Mendiola Health Center in honor and memory of the late Vicente Mendiola who had dutifully served as Mayor of the then Municipality of Naga, Cebu for more than twenty (20) years;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This ordinance shall be known: "AN ORDINANCE NAMING THE NEW HEALTH CARE BUILDING OF THE CITY OF NAGA, CEBU AS VICENTE MENDIOLA HEALTH CENTER."

SECTION 2. COVERAGE: The Vicente Mendiola Health Center shall comprise the City Health, Birthing Center, Animal Bite Treatment Center, TB-DOTS and other health services with the purpose of providing immediate and quality health care services to the city residents in response to their health or medical needs;

SECTION 3. OFFICIAL NAME: Vicente Mendiola Health Center, as its official name, will be used in all official transactions deemed necessary to the facility.

SECTION 3. FUNDS REQUIREMENT – An appropriation of funds subject to specific program of work and financial plan for the operation and sustainability of this new health facility shall be taken from the funds of the City Government and that the appropriation amount may be increased as the need arises for any given year subject to the usual government accounting and auditing requirements.

SECTION 5. SEPARABILITY CLAUSE – Should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.



SECTION 7. COPIES FURNISHED CLAUSE – Let copies of this Ordinance be furnished to the National Historical Institute, Office of the City Mayor and other offices concerned for their information, guidance and documentation.


SECTION 8. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval in accordance with law.


